Notification of carriageway reconstruction works on the A511 Horninglow Road North, Burton Upon Trent

Following on from the letter that was sent out on the 13 December 2023 regarding the upcoming works on the A511 Horninglow Road North, from the junction of Horninglow Croft to north of the junction of Farm Road.

We are now able to provide you with more details regarding the remaining works, including the surfacing phases and road marking phase, along with details about the road closures and access arrangements during this work.

As part of our ongoing works on Horninglow Road North and to minimise future disruption to the local community, we will be working in collaboration with Severn Trent Water, to enable them to carry out repairs to their apparatus. This will enable them to undertake their repairs, for which they will require a road closure. Severn Trent's permitted work will take place from **Saturday 10 February to Monday 12 February 2024**, this is near to Horninglow Primary School. During this time, Staffordshire County Council will also be carrying out utility survey works along the full length of the scheme, ahead of the carriageway surfacing works.

Please see the table below, which provides details about the road closures, working times for both daytime and nighttime work, along with details about the remaining phases of our work.

Due to the size and scale of construction machines being used and to ensure the safety of the general public and workforce, sections of the carriageway will at times become impassable and therefore, it will be necessary to close sections of the road to through traffic. Various temporary road closures will be in place during the remaining phases of works.

A primary road diversion route will be in place for through traffic during the closures.

Local signed diversion routes will be in place during the individual closures; along with designated personnel at either end of the closure points to offer assistance and assist with access when safe to do so. **Businesses along the route will be open as usual** and access will be maintained, however at times access may not be possible within the areas of work for short periods. This is for both your safety and the safety of the workforce.

Pedestrian access along the length of the works will be maintained throughout.

Emergency services will be given access through the road closures.

Unfortunately, with any major highway works, some disturbance is unavoidable, and there may be short delays even on the approaches to the closure points. I must ask that you drive carefully and slowly through any sections of live roadworks for both the workforces and your own safety.

During the road closure period, waste and recycling collections will remain the same, with on their normal collection delays.

Please note that all dates are subject to change due to operational requirements and weather conditions. Some weekend working may be used where necessary.

The works may at times be noisy, and we apologise in advance for any inconvenience or disturbance caused. We'll do our best to complete the work as quickly and safely as possible. We like to thank you for your patience during this works.
