IR: Recent Changes

Immigration changes from 9 April 25

- Minimum salary threshold increased to £12.82/hour or £25,000p.a. (based on 37.5 hours/week), whichever is higher (up from £11.90/hour or £23,200p.a.)
 - Change applies to new visa applications / extensions submitted after 9/4/25
- Increases to other <u>Home Office immigration fees</u>, including an increase to the Certificate of Sponsorship fee, from £239 to £525
- Before sponsoring a new overseas care worker, providers must evidence they have tried to recruit from the UK displaced worker pool. In the West Midlands Lifted are managing this process and the displaced worker pool, and there is a regional support offer. Two exceptions:
 - Care Worker/ Senior Care Worker previously granted permission as Skilled Worker and sponsored under the 6135 / 6136 SOC codes
 - Care Worker/Senior Care Worker legally working for provider in role, with permission on another immigration route, for at least 3 months before application date

IR: Recent Changes

White Paper - Restoring Control over the Immigration System published 12 May 2025:

- Intention that care worker/senior care worker recruitment from abroad via the Health and Care Worker visa route will come to an end later this year.
 - Other care roles not affected (e.g. managers, nurses)
- During the transition period until 2028 care workers in the UK on valid visas will be allowed to extend their visas, change sponsors and apply for settlement
- Alongside the closure of the visa route, the White Paper commits to the introduction of a Fair Pay Agreement (FPA) for the adult social care sector in England.

IR: Provider Support

- The <u>Lifted</u> regional support offer was updated following the immigration rule changes in April and is now:
 - Match only service free to West Midlands care providers
 - Full support service (£99 per month per hire (while employed) for a maximum of 3 years)

- Lifted continue to evolve their service following feedback. Recent changes include:
 - Dedicated support email for care providers and recruitment leads <u>support@lifted-</u> talent.com
 - Providers can now view candidates based on geographical radius from their location
 - Application process updated to allow candidates to specify their relocation preferences more clearly
 - Care workers can accept job offers directly through the platform
