Communication

Assessment and Care Management

The <u>Midlands Partnership NHS Foundation Trust</u> (MPFT) and the Adult Learning Disability Team (ALDT) are the two main assessment and care management organisations in Staffordshire.

They are primarily contacted through <u>Staffordshire Cares</u> but <u>duty teams</u> can also directly be reached.

Integrated Care System (ICS)

The <u>Staffordshire and Stoke-on-Trent integrated Care System</u> works with local people, communities, and staff to improve the health and wellbeing of individuals and to use their collective resources more effectively.

Integrated Care Board (ICB)

The <u>Staffordshire and Stoke-on-Trent Integrated Care Board</u> is responsible for local NHS functions and budgets.







MiDoS for CARE

<u>MiDoS for CARE</u> has been designed as an online information hub for care services in Staffordshire and Stoke-on-Trent.

It provides access to a wide range of supportive information, which includes elements of the NHS directory of services (DoS), links to various community teams and a wide range of guidance and information from a variety of sources.

The platform is available to all registered care homes, home care services and supported living providers in Staffordshire and Stoke-on-Trent.

If your **care service** is registered in **Staffordshire**, you should contact **midosforcare@staffordshire.gov.uk**.

If your **care service** is registered in **Stoke-on-Trent**, you should contact **qualityassurance@stoke.gov.uk**.

If your care service is not registered in either Local Authority but you have a contractual relationship with one of the Local Authorities, you should contact that Local Authority for access.

Care Market Development Team

The team are responsible for supporting the care market with developing training opportunities, maximising access to development funding, recruitment and retention, and networking opportunities.

Staffordshire and Stoke-on-Trent Wellbeing Service

The <u>Staffordshire and Stoke-on-Trent Wellbeing Service</u> is a team of NHS professionals trained to specialize in offering effective, evidence-based treatments for a wide range of common problems that affect most of us at some point in our lives.

They specialize in all symptoms of anxiety, and low mood (depression), but we also deliver physical rehabilitation programmes for physical conditions and help people to live better with long term physical conditions.

They treat both emotional and physical symptoms together – because people all experience both in our lives. The team is made up of Wellbeing Practitioners, Nurse Therapists, Cognitive Behavioural Therapists, and Counsellors.

Skills for Care

<u>Skills for Care</u> is the strategic workforce development and planning body for adult social care in England. They work with employers, Government and partners to ensure social care has the right people, skills and support required to deliver the highest quality care and support now and in the future.

Their local area teams across England work directly with adult social care providers, as well as a wide range of other partners within the local health and care systems.

Staffordshire Care Association

SARCP is a long-standing well-respected association representing over 200 independent Care Providers including Care Homes and Home Care Agencies in discussions with government agencies.

SARCP has an Executive Committee made up of eleven independent care provider proprietors/senior Managers and professional consultants. Members are given helpful advice and kept informed of changes both nationally and locally ensuring that they are aware of factors that impact the sector.

Staff development is important to their Members and SARCP facilitates training courses to support staff development and recruitment. SARCP offers a full DBS checking facility and is always on hand for advice and staff training.

Support for Staff

Vivup

As a Commissioned care service, you and your staff are eligible to access the **Vivup rewards programme** though the County Council. The registration process can be located **online**.

Blue Light Card

Blue Light Card provides those in the NHS, emergency services, social care sector and armed forces with discounts online and in-store.

Staff within your care home are eligible to **register for a Blue Light Card**.

Leadership Support

There is a range of support available from Skills for Care, to support you and your leadership team.

Workforce Development Fund

The <u>Workforce Development Fund</u> is funding from the Department of Health and Social Care which is distributed by Skills for Care through a network of partnerships. The Care Market Development Team administers the partnership in Staffordshire and distributes the funds to members.

The fund is only available to adult social care employers with an **Adult Social Care Workforce Data set account** with specific organisational, workforce and staff records completed.

The fund allows you to claim back money towards the cost of staff completing a broad range of adult social care qualifications, learning programmes and digital learning modules but can only be claimed once a candidate has completed their full qualification.

Employers pay any required fee to their learning provider as usual and then funding is payable upon completion of the qualifying course and provision of the achieved certificate.
