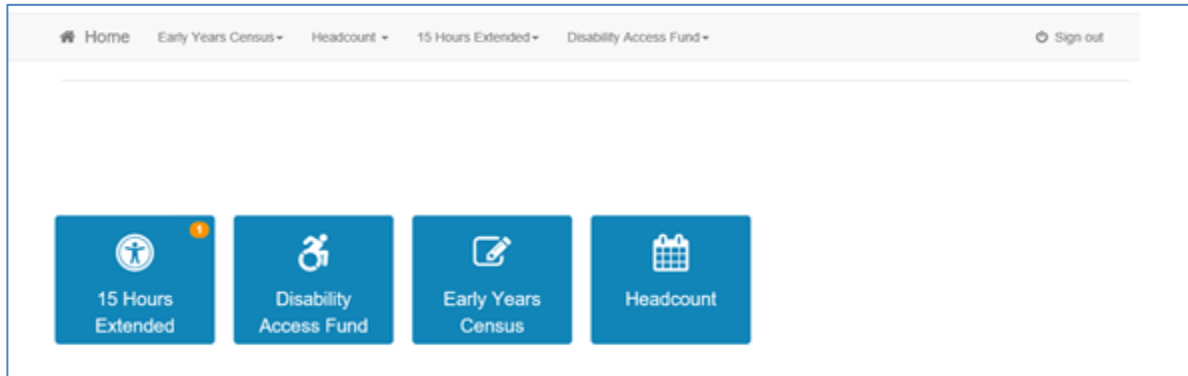


Disability Access Fund (DAF) Provider Application Process

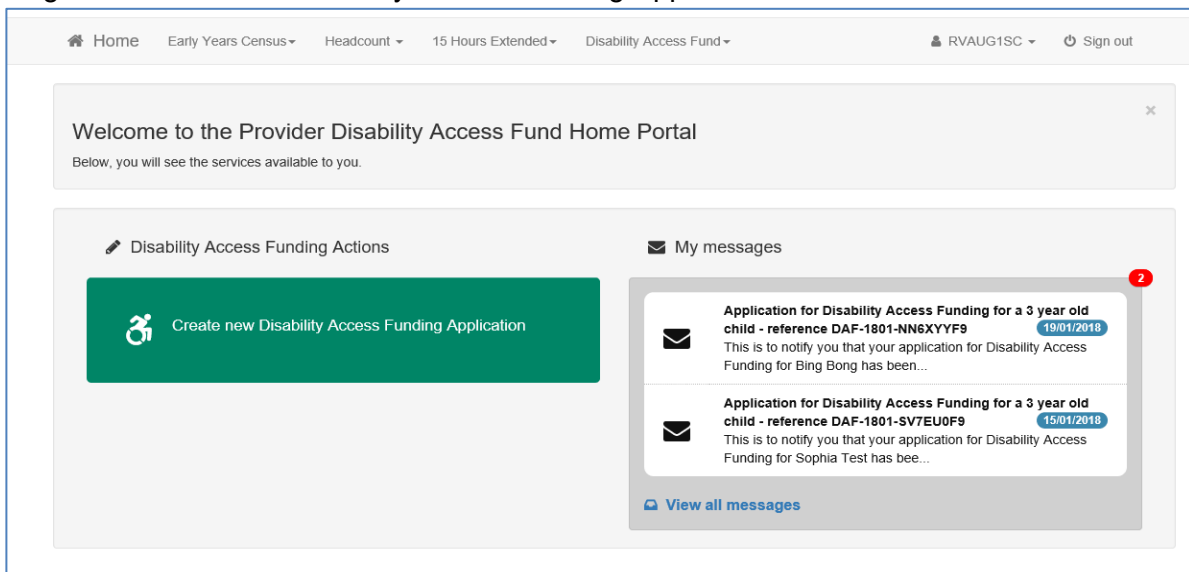
These steps are to show a Provider how to complete an application form for Disability Access Funding for a child at their setting.

How to complete a Disability Access Fund (DAF) Application Form


When you log in to the Provider Portal, you will be taken to the main Home Page.
Click on blue 'Disability Access Fund' button:-



Click on green 'Create new Disability Access Funding Application' button:-




Check that your own setting has been selected and click the blue 'Continue' button at bottom right to start your application.



A list of children already registered at your setting will be displayed along with their Age Eligibility (non-eligible children will have their selection box at left of their name greyed out).

To select the correct child, type their name or date of birth into the 'Find a Child' box. If the child is already registered at the setting, the child will be displayed.





Click the selection button to the left of the child and click the 'Continue' button.


If the child is not eligible for DAF the selection button will be greyed out and you should exit the application using the 'Cancel' button at the bottom left of the screen.

If the child is not already registered at the setting, click the 'Add Child' button at the bottom right of the screen.

Complete all details for the child and click 'Continue' at the bottom right of the screen.



The following screen will be displayed. To upload the DLA Award Letter into the application, click 'Browse' and follow the onscreen prompts to locate and upload it. Documents are accepted in the following formats:- png, jpg, jpeg, pdf, doc, docx. Documents should be no larger than 1Mb so only upload the front page of the letter, showing name and address of child and period of award, which must be current. Do **not** tick the 'I will provide DLA Award Letter by post' box as this will remove the uploaded form and you will have to upload it again.



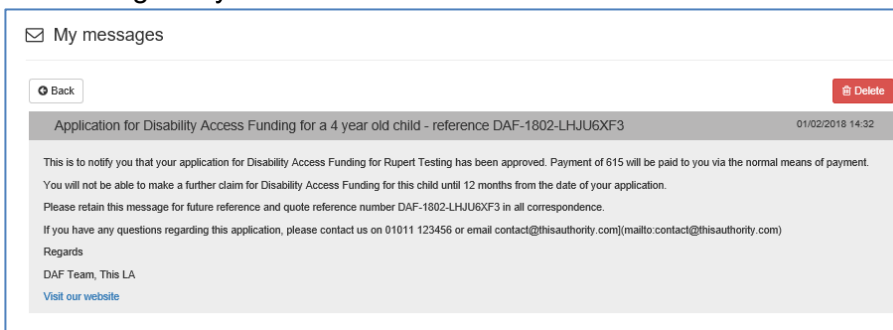

Reasons for Rejection of a DAF Application

A DAF application may be rejected for the following reason(s):

1. If a DAF payment has already been made to another provider within the previous 12 months (for example, if the child moves provider within 12 months).
2. If child is not the correct age; DAF is only applicable to 3 and 4 year olds.
3. No evidence is supplied – if the application is made but no DLA Award letter is submitted via the portal or by post the application cannot be processed.
4. The DLA Award detailed on the Award letter supplied has expired – i.e. DLA was awarded to 2016 and there is no further date to say it is continuing. The DLA Award needs to be current at the time of the application.
