

Ownership Certificates and Agricultural Land Declaration

(version 12 June 2015)

The certificates and declaration are provided for applications for minerals development only. Certificates are provided on the standard application form which should be completed when applying for planning permission for waste development or the County Council's own development.

In accordance with the Town and Country Planning (Development Management Procedure) (England) Order 2015 - <u>Article 14</u> an application for minerals development must be accompanied by one Certificate A, B, C, or D (or the appropriate certificate in the case of underground mining operations)



CERTIFICATE OF OWNERSHIP - CERTIFICATE A
