

PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER HIGHWAYS ACT 1980 WILDLIFE AND COUNTRYSIDE ACT 1981

STAFFORDSHIRE COUNTY COUNCIL

(PUBLIC FOOTPATH NO. 13 (PART) ELLASTONE PARISH) PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2017

This Order is made by Staffordshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the Borough of East Staffordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this order) of a highway shown or required to be shown in the map and statement.

The landowners have agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

East Staffordshire Borough Council and Natural England have been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act;

BY THIS ORDER

- 1. The public right of way over the land situated at Ellastone and shown by a bold continuous line on the map contained in this Order and described in [Part 1 of] the Schedule to this Order shall be stopped up on the date on which Staffordshire County Council certify that work has been carried out to bring the site of the new highway mentioned in paragraph 2 into a fit condition for use by the public, and thereupon the Definitive Map for the Borough of East Staffordshire shall be modified by deleting from it that public right of way.
- 2. There shall from the date of the above mentioned certification be a public footpath over the land situate at Ellastone and described in [part 2 of] the Schedule and shown by a bold broken line on the map contained in this Order and thereupon the Definitive Map for the Borough of East Staffordshire shall be modified by adding that path to it.

- 3. The Definitive Statement for the Borough of East Staffordshire shall be modified as described in Part 4 of the Schedule to this Order.
- 4. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of Public Footpath No. 13 Ellastone Parish running from its junction with the farm track at point A on the Order plan (413651 343627) in a generally north-easterly direction for approximately 18 metres then in a generally east south-easterly direction for approximately 14 metres then in a generally east-north-easterly direction for approximately 85 metres to its junction with the southern end of Public Footpath No 31 Ellastone at point B on the Order plan (413754 343669) before continuing in a generally easterly direction across a field and then through the grounds of Grove Cottage for approximately 130 metres then in a generally north north-easterly direction for approximately 41 metres then in a generally east north-easterly direction for approximately 16 metres to the farm track at point C on the Order plan (413920 343698).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY


A new length of Public Footpath No. 13 Ellastone Parish running from its junction with the farm track at point A on the Order plan (413651 343627) in a generally north north-westerly direction for approximately 22 metres to point D on the Order plan (413642 343646) before heading in a generally east north-easterly direction along the farm track for approximately 126 metres to point E on the Order plan (413758 343699) and continuing in a generally east north-easterly then south easterly direction following the farm track for approximately 188 metres to point C on the Order plan (413920 343698).

The new route of Public Footpath No 13 Ellastone Parish shall have a prescribed width of 3 metres between points A-D-E-F-C on the Order plan.
