**PUBLIC FOOTPATH NO. 0.799 (PART) CANNOCK TOWN
PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER 2016**

This Order is made by Staffordshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order, it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A(2) of the Wildlife & Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the District of Cannock Chase require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely the diversion (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

Staffordshire County Council has agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition or use by the public.

Cannock Chase District Council have been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public right of way over the land situate at Cannock Town and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order, and thereupon the Definitive Map for the District of Cannock Chase shall be modified by deleting from it that public right of way.

2. There shall, at the end of 28 days from the date of confirmation of this Order, be a public footpath over the land situate at Cannock Town described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order and thereupon the Definitive Map for the District of Cannock Chase shall be modified by adding that path to it.

3. The Definitive Statement for the District of Cannock Chase shall be modified as described in Part 4 of the Schedule to this Order.

4. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of public footpath No. 0.799 Cannock Town running from its junction with Public Footpath No 0.800/0.801 Cannock Town at point A on the Order plan (403196 309858) and heading in a generally northerly direction for approximately 884 metres to its junction with Public Footpath No 65 Cannock Town at point B on the Order plan (403012 310701).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A new length of public footpath No. 0.799 Cannock Town running from its junction with Public Footpath No 0.800/0.801 Cannock Town at point C on the Order plan (403162 309824) in a generally north north-westerly direction for approximately 86 metres to point D on the Order plan (403131 309901) then heading in a generally east north-easterly direction for approximately 56 metres to point E on the Order plan (403178 309933) before heading in a generally northerly direction for approximately 70 metres to point F on the Order plan (403156 309998). The footpath then heads in a generally east north-easterly direction for approximately 244 metres to point G on the Order plan (403376 310100) before turning to head in a generally northerly direction for approximately 617 metres to its junction with Public Footpath No 65 Cannock Town at point H on the Order plan (403235 310694).

The new route shall have a prescribed width of 2.5 metres between points C-D-E-F-G-H.

LIMITATIONS AND CONDITIONS

~~The County Council will remove any existing footpath signage from the current definitive line and erect 'Path Diverted, Please Follow Waymarked Route' signs at either end. Footpath signage will be installed on the new route of Public Footpath No 0.799 Cannock Town.~~

A pedestrian kissing gate in accordance with BS5709:2006 will be installed at point H (403235 310694) as shown on the Order plan.

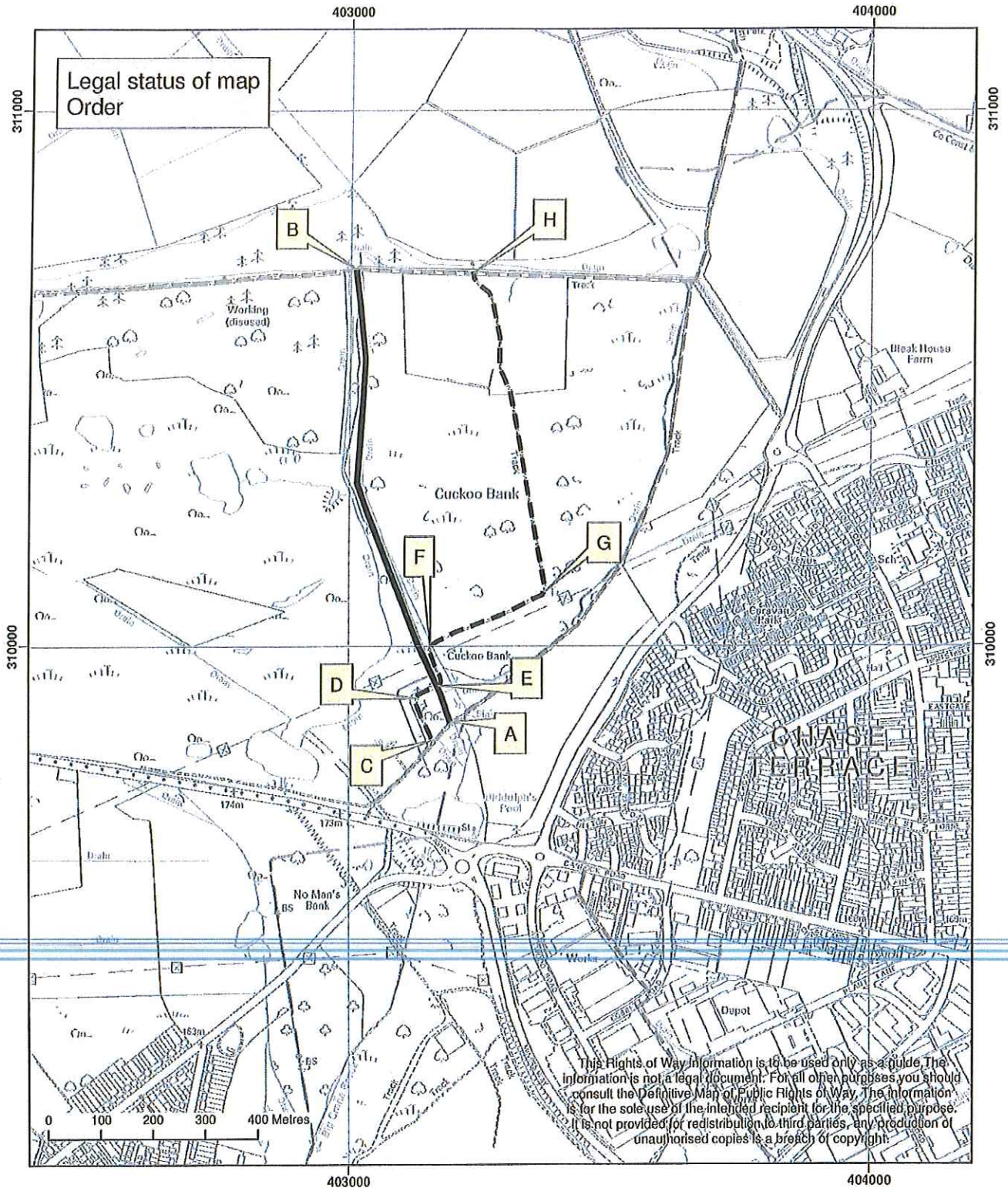
