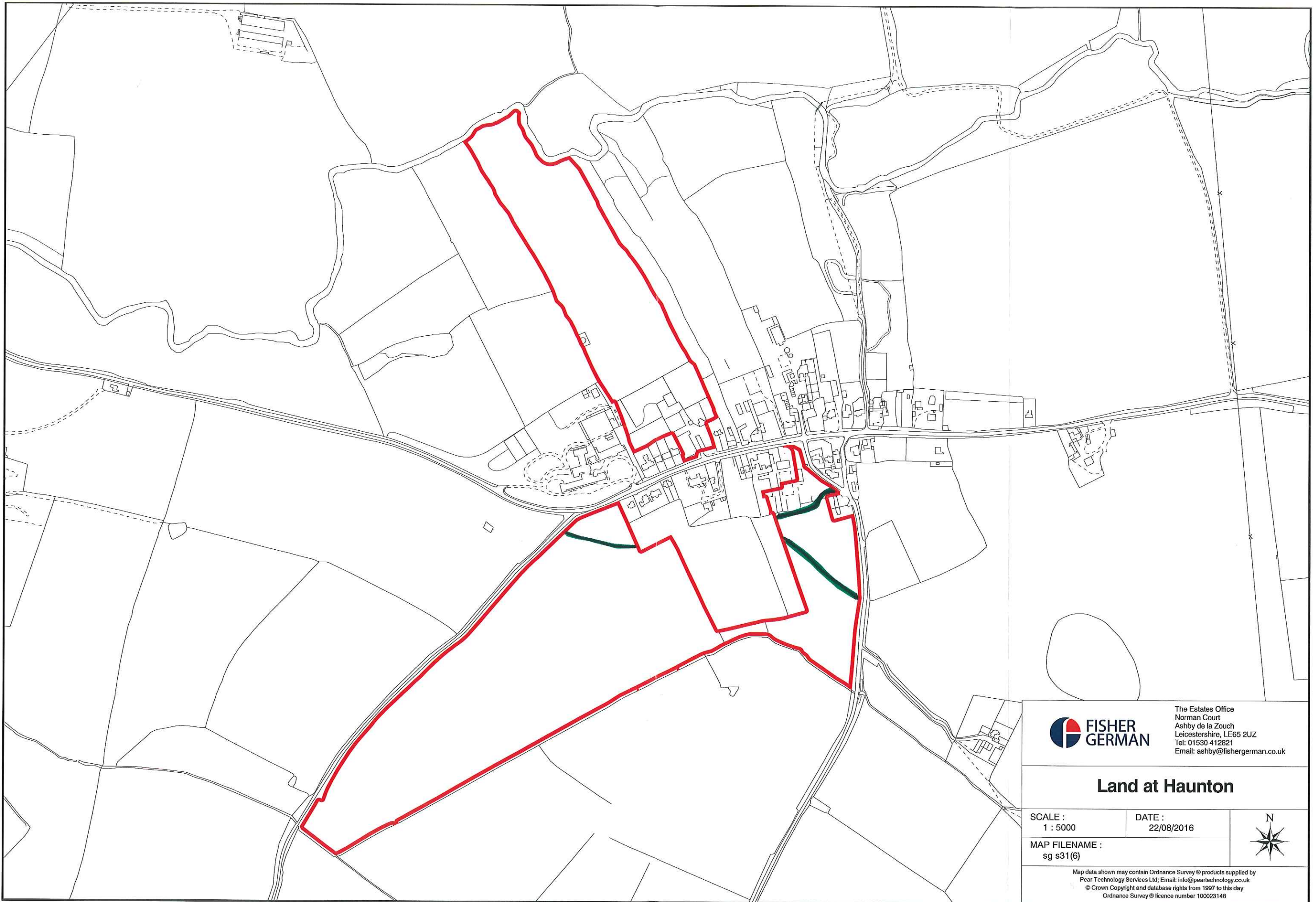
**Data Protection Act 1998 – Fair Processing Notice**
