Dear Sir/Madam,

A4601 Avon Road, Wolverhampton Road, Longford Road.

I write with reference to the highway improvement scheme due to commence in Cannock.

You may already be aware that the structural carriageway surfacing scheme is due to commence on 26.6.2023. Preparation civils work will focus on drainage, kerbing, footway, and ironwork, to allow a shorter duration of closure times for each surfacing phase.

We will shortly be carrying out surfacing in sections of full width carriageway, in phases between the junction of A005 Watling Street and Wellington Drive then from The Cedars Business Centre to the roundabout and its approaches of Longford Road, then to continue to A034 Walsall Road.

Carriageway surfacing works are due to begin on 24.07.2023 with completion of all works due on 03.09.2023. Some weekend working may be used where necessary.

During this time, we will resurface the carriageway, reset or replace ironwork, replace traffic sensing loops for the signals, replace damaged street furniture and replace road markings throughout.

Due to the nature and scale of the plant used in a complex operation such as this, sections of carriageway will at times become impassable. In order for activities to take place safely, it will be necessary to temporarily close the route to through traffic, hence various temporary road closures will be in place over the course of the surfacing phases.

I have outlined on the reverse of this letter in the form of a table, the days/nights, and times when the respective sectional closures will be in place.

A signed diversion route will be in position for the individual closures; along with designated personnel at either end of the closure points to offer advice; and the direction of your travel will be determined by the whereabouts of the workforce at that time, as per the details on the reverse of this letter.

Our crews will do all that they can to assist you with access, however at times access may not be possible within the areas of work during the times stated. This is for both your safety and the safety of the workforce. Pedestrian access will be maintained and parking areas within the closure will be available for short durations should you require it, by speaking to the TM operatives on site.

In the case of an emergency, emergency vehicles will be granted access when safe to do so.

Unfortunately, with any major highway works, some disturbance is unavoidable, and there may be short delays even on the approaches to the closure points. I must ask that you drive carefully and slowly through any sections of live roadworks for both the workforces and your own safety.
