**PUBLIC PATH CREATION AND DEFINITIVE MAP AND STATEMENT  
MODIFICATION ORDER 2017**

This Order is made by Staffordshire County Council ("the authority") under Section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that having regard to the matters set out in Section 26(1), there is a need for a public footpath over the land to which this Order relates, and that it is expedient that the path should be created.

This Order is also made under Section 53A(2) of the Wildlife & Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the District of Staffordshire Moorlands require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely the creation (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

Staffordshire County Council has agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition or use by the public.

Staffordshire Moorlands District Council have been consulted and have consented to the making of the Order as required by Section 26(3) of the 1980 Act.

**BY THIS ORDER**

1. There shall be, at the end of 28 days from the date of confirmation of this Order, a public footpath over the land at Leek Town described in (part 1 of) the Schedule to this Order and shown by a bold broken line on the map attached to this Order.
2. The Definitive Statement for the District of Staffordshire Moorlands shall be modified as described in Part 4 of the Schedule to this Order.
3. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

**SCHEDULE**

**PART 1**

**DESCRIPTION OF SITE OF NEW PATH OR WAY**

A new length of Public Footpath in Leek Town running from its junction with Nab Hill Avenue at a point in between properties 37 and 39 Nab Hill Avenue at point A on the Order plan (397607 356638) and running in a generally south south-westerly direction for approximately 33 metres to point B on the Order plan (397600 356607) then heading in a generally east south-easterly direction for approximately 45 metres to point C on the Order plan (397642 356594) before heading in a generally south south-westerly direction for approximately 35 metres to its junction with North Street at point D on the Order plan (397631 356562).

The new route shall have a prescribed width of 1 metre between points A-B-C-D.

There are steps on the Public Footpath between points A and B. There are no other limitations or conditions.

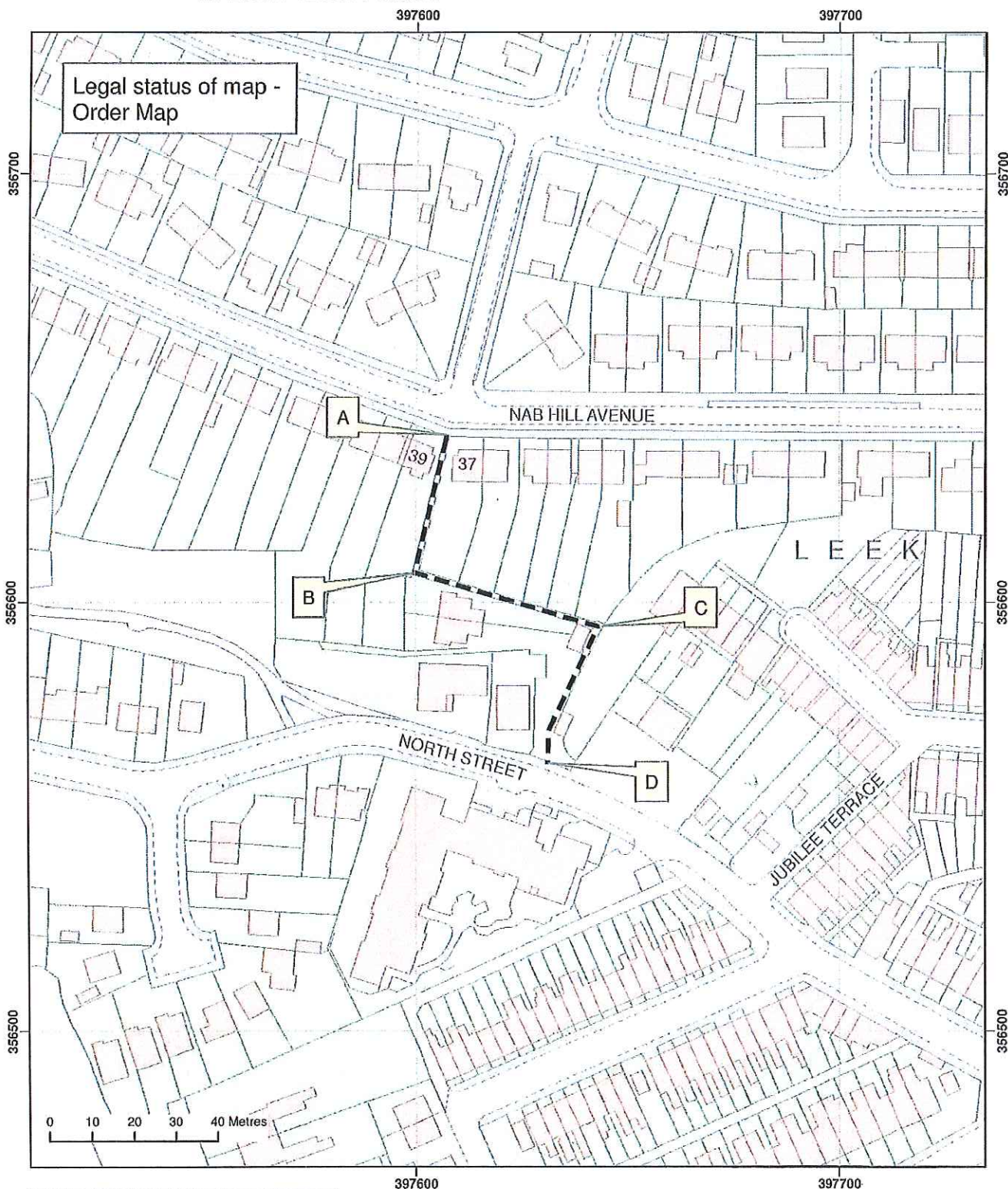
