PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2017

This order is made by Staffordshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath as described in paragraph 1 of this Order, it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A (2) of the Wildlife & Countryside Act 1981 (the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the district of South Staffordshire requires modification in consequence of the occurrence of an event specified in Section 53(3) (a) (i) of the 1981 Act, namely the diversion (as authorised by this Order) of the highways shown or required to be shown in the Map and Statement.

The landowner has agreed to pay any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

South Staffordshire District Council has been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

- 1. The public rights of way footpath over the land situated at Coppenhall and shown by a bold black line on the map contained in this Order and described in part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.
- 2. There shall, at the end of 28 days from the date of confirmation of this Order, be a public footpath over the land situated at Coppenhall described in part 2 of the Schedule and shown by bold broken dashes on the map contained in this Order.
- 3. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of Public Footpath No.9 Coppenhall Parish commencing point A on the Order plan (NGR 391030 319318) and continuing in a generally south south-westerly direction for approximately 44 metres to point B on the Order plan (NGR 391022 319274).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A new length of Public Footpath No. 9 Coppenhall Parish commencing from point A on the Order plan (NGR 391030 319318) and continuing in a generally southwesterly direction for approximately 22 metres to point C on the Order plan (NGR 391013 319303) and continuing in a generally south-westerly direction for approximately 10 metres to point D on the Order plan (NGR 391006 319296).

The new route of Public Footpath No.9 Coppenhall Parish shall have a prescribed width of 1.8 metres between points A (NGR 391030 319318) and D (NGR 391006 319296) on the Order plan, other than when passing through a gap at the north-westerly side of the cattle grid at point C (391013 319303) on the Order plan.


