**PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER 2016**

This Order is made by Staffordshire County Council ("the authority" under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order, it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A(2) of the Wildlife & Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the Borough of East Staffordshire require modification in consequence of the occurrence of an event specified in Section 53A(a)(i) of the 1981 Act, namely the diversion (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

The land owner has agreed to defray any expenses which are incurred in bringing the site of the path into a fit condition for use by the public.

East Staffordshire Borough Council has been consulted with regards to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public rights of way over the land at Denstone Parish in Borough of East Staffordshire, shown by a bold continuous black line on the attached map and described in part 1 of the Schedule to this Order after 28 days from the date of confirmation of this Order.
2. There shall, at the end of 28 days from the date of confirmation of this Order, be public footpaths over the land situate at Denstone Parish in the Borough of East Staffordshire as provided in Part 2 of the Schedule and shown by bold black broken lines on the attached.
3. The Definitive Statement for the Borough of East Staffordshire shall be modified as described in Part 4 of the Schedule to this Order.
4. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH

The entire length of Public Footpath No.24 commencing at Denstone Lane at point A on the Order map (408882 341362) running in a generally north northwesterly direction for approximately 60 metres to point B on the Order map (408874 341422) continuing in a generally northerly direction for approximately 243 metres to point C on the order map (408920 341659) continuing in a generally northerly direction for approximately 211 metres to its junction with Public Bridleway No.26 Denstone Parish on Saltersford Lane at point D on the Order map (408907 341869).

PART 2

DESCRIPTION OF SITE OF NEW PATH

A new length of Public Footpath commencing at Denstone Lane at point A on the Order map (408882 341362) running in a generally northerly direction for approximately 292 metres to point E on the Order map (408944 341648) then in a generally northerly direction for approximately 142 metres to point F on the Order map (408980 341786) continuing in a generally northerly direction for approximately 77 metres to its junction with Public Bridleway No.26 Denstone Parish on Saltersford Lane at point G (408985 341862) on the Order map.

PART 3

LIMITATIONS AND CONDITIONS

In accordance with BS5709 : 2006 two stiles are to be installed on the route, one at point F (408980 341786) and one at point G (408985 341862) of the Order Plan.

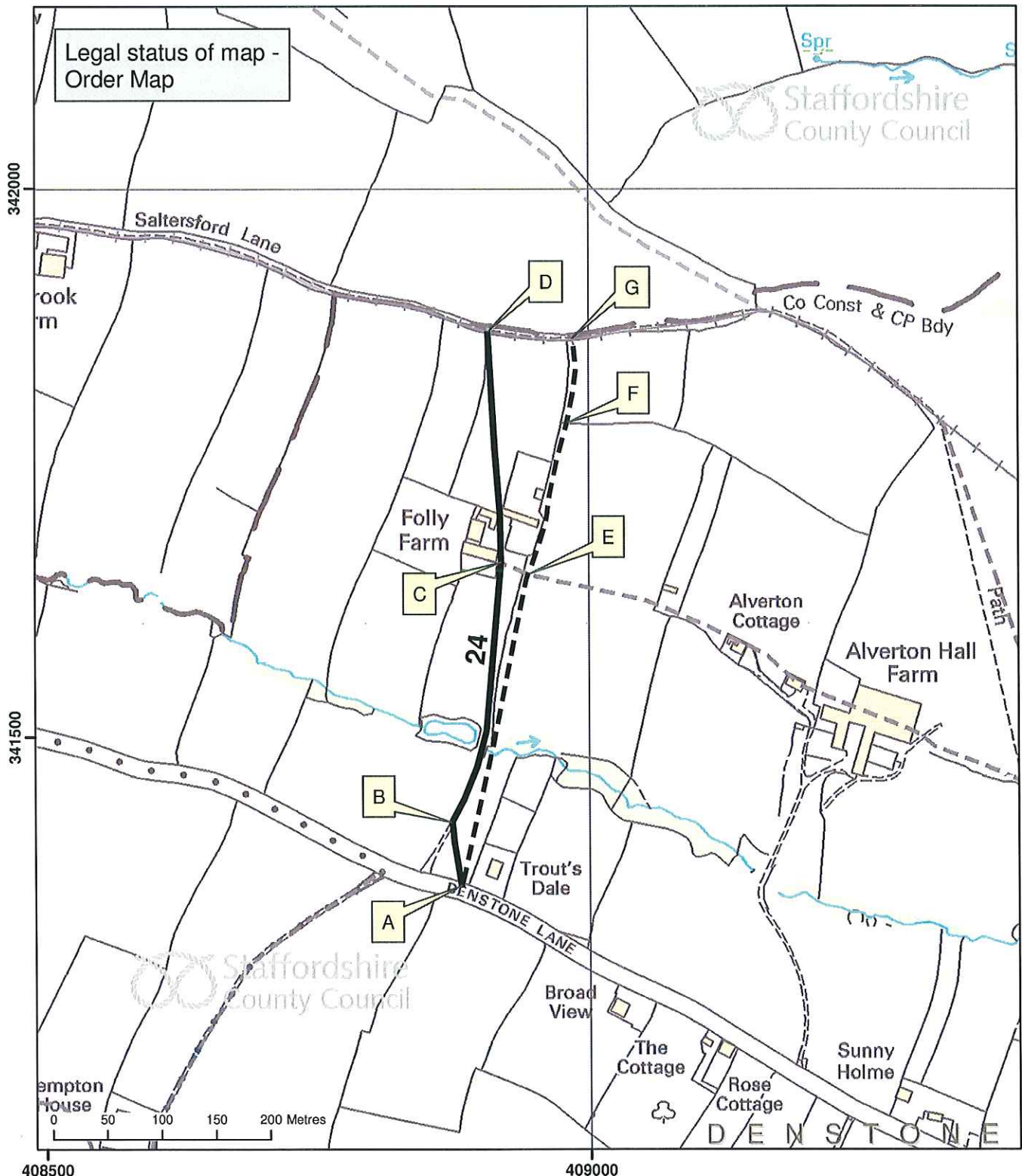
