PUBLIC PATH EXTINGUISHMENT AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2016

This Order is made by Staffordshire County Council ("the authority" under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner the land crossed by the footpath described in paragraph 1 of this order, it is expedient that the line of the path should be extinguished

This Order is also made under Section 53A(2) of the Wildlife & Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the Borough of East Staffordshire require modification in consequence of the occurrence of an event specified in Section 53A(a)(i) of the 1981 Act, namely the diversion (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

East Staffordshire Borough Council has been consulted with regards to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public rights of way over the land at Denstone Parish in Borough of East Staffordshire, shown by a bold continuous black line on the attached map and described in part 1 of the Schedule to this Order shall be extinguished 28 days after the date of confirmation of this Order.
2. The Definitive Statement for the Borough of East Staffordshire shall be modified as described in Part 2 of the Schedule to this Order.

That part of Public Footpath No.25 Denstone Parish commencing at its junction with Public Footpath No.24 Denstone Parish, point A on the Order map (408920 341659)

and running in an east south easterly direction for 26 metres to point B on the Order Map (408944 341648).

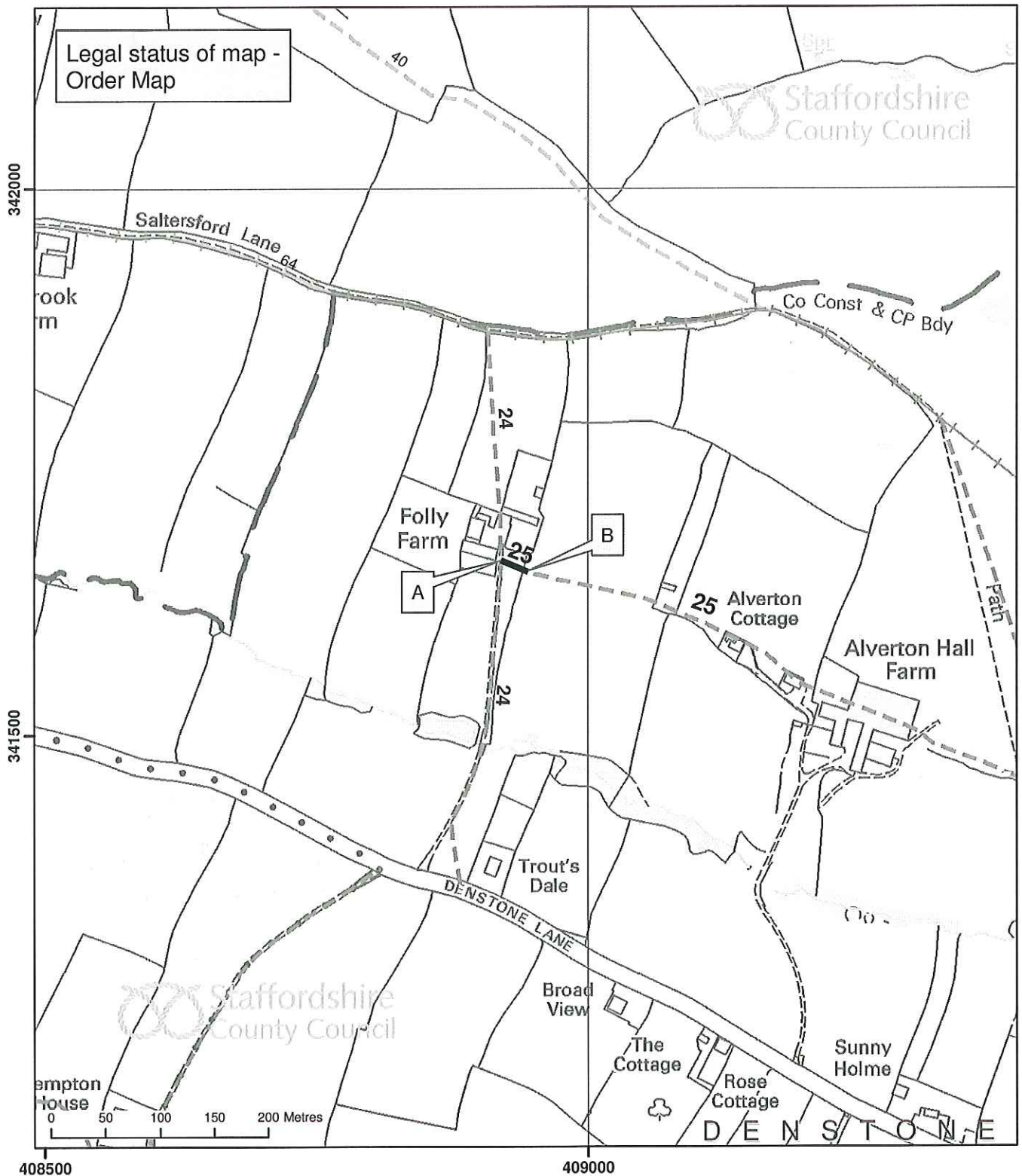
