PUBLIC PATH DIVERSION ORDER

HIGHWAYS ACT 1980

**PUBLIC FOOTPATH NO.13 (PART) CASTLE CHURCH PARISH
PUBLIC PATH DIVERSION ORDER 2017**

This order is made by Staffordshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath as described in paragraph 1 of this Order, it is expedient that the line of the path should be diverted.

The landowner has agreed to pay any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Stafford Borough Council has been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public rights of way footpath over the land situated at Castle Church and shown by a bold black line on the map contained in this Order and described in part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.
2. There shall, at the end of 28 days from the date of confirmation of this Order, be a public footpath over the land situated at Castle Church described in part 2 of the Schedule and shown by bold broken dashes on the map contained in this Order.
3. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

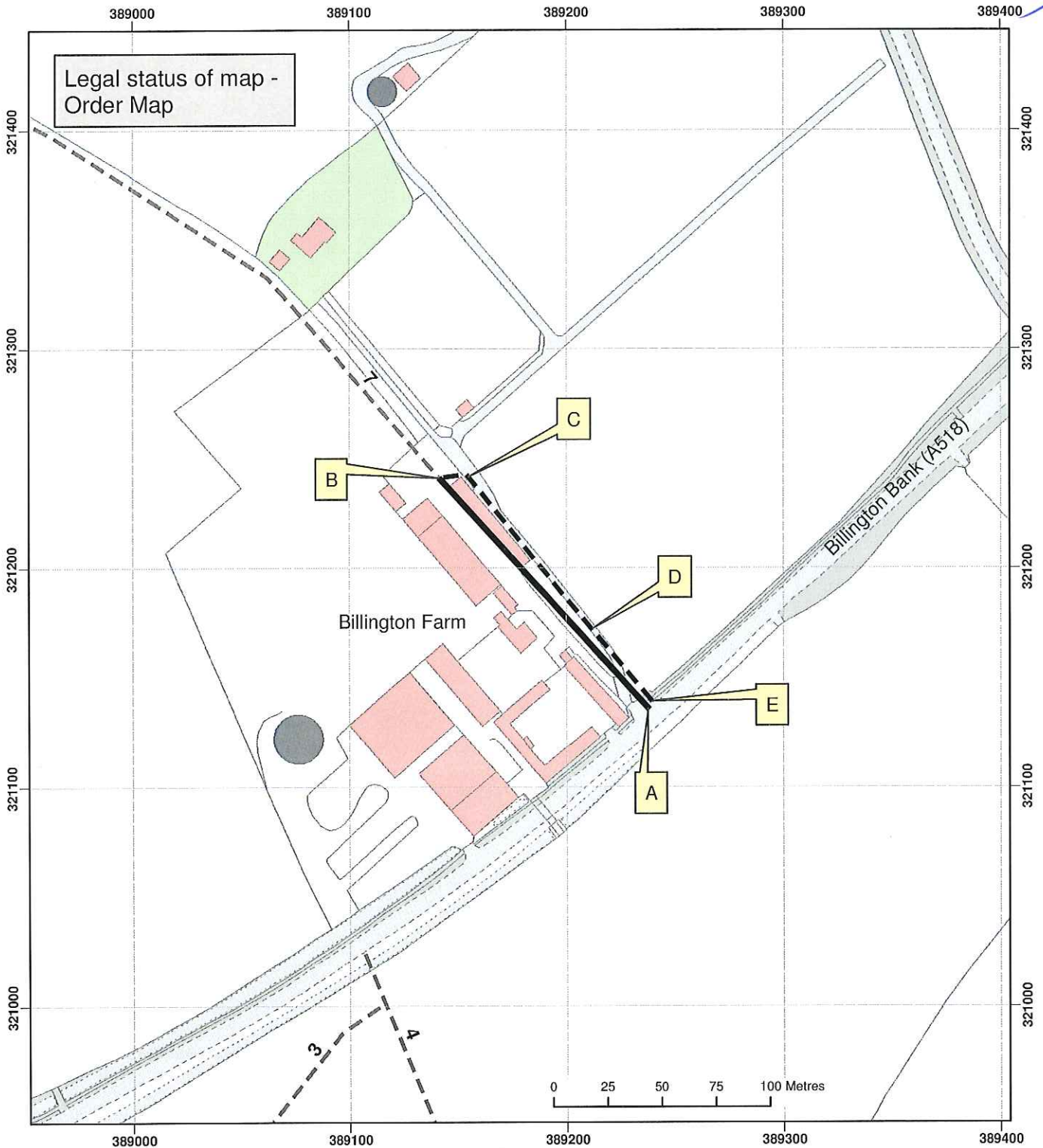

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of Public Footpath No.13 Castle Church Parish commencing point A on the Order plan (NGR 389237-321135) and continuing in a generally north-westerly direction for approximately 143 metres to point B on the Order plan (NGR 389141-321241).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A new length of Public Footpath No.13 Castle Church Parish commencing from point E on the Order plan (NGR 389239-321138) and continuing in a generally north-westerly direction for approximately 43 metres to point D on the Order plan (NGR 389211-321172) and continuing for approximately 90 metres in a generally north-westerly direction to point C on the Order plan (NGR 389154-321241) and continuing for approximately 14 metres in a westerly direction to point B on the Order plan (NGR 389141-321241).

The new route of Public Footpath No.13 Castle Church Parish shall have a prescribed width of 1.8 metres between points E (NGR 389239-321138), D (NGR 389211-321172), C (NGR 389154-321241) and B (NGR 389141-321241) on the Order plan, other than when passing through the pedestrian stiles at points E (NGR 389239-321138) and D (NGR 389211-321172) on the Order plan.

PART 3

LIMITATIONS AND CONDITIONS

A pedestrian stile in accordance with BS5709:2006 is installed at point E (NGR 389239-321138) and point D (NGR 389211-321172) as shown on the Order Plan. The owner of the land is responsible for the maintenance of the surface of the diverted section of Public Footpath No.13 Castle Church Parish to a standard required by Staffordshire County.
