CYCLE TRACK (NO. 18 SILVERDALE PARISH) CYCLE TRACK ORDER 2015

The Order is made by Staffordshire County Council ("the authority") under Section 3 of the Cycle Tracks Act 1984 ("the 1984 Act") because it appears to the authority that it is in the interest of the public, that the footpath described in paragraph 1 of this order should be re-classified as a Cycle Track.

The developer Ibstocks Group Limited has agreed to defray any expenses which are incurred in bringing the site of the Cycle Track into a fit condition for use by the public.

Newcastle-under-Lyme Borough Council has been consulted to the making of the Order.

BY THIS ORDER

- The public rights of way over the land situate at Silverdale in the Borough of Newcastle-under-Lyme and shown by bold green lines on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be reclassified after 28 days from the date of confirmation of this Order.
- 2. There shall at the end of 28 days of the confirmation of this Order, be a Cycle Track over the land situate at Silverdale Parish in the Borough of Newcastle-under-Lyme as described in Part 2 of the Schedule to this Order and shown by bold green lines on the map contained in this Order.
- The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule to this Order.
- 4. The Cycle Track shown by bold green lines on the map contained in this Order and described in Part 2 of the Schedule to this Order shall be recorded in the list of Publically Maintainable Highways kept by the authority under Section 36 of the Highways Act 1980.

A Public Footpath commencing (point A on the attached plan) on the north side of Church Street, Silverdale, approximately 22 metres east of the junction of Crown Street and Church Street and running in a generally northerly direction for approximately 23m. then in a generally north-easterly direction for approximately 17m. then in a generally northerly direction for approximately 6m. to its terminus at the junction of public footpath nos.18 and 19 Silverdale Parish (point C on the attached plan).

Width - from A - B 4.5 metres

from B - C 3 metres

A Cycle Track commencing (point A on the attached plan) on the north side of Church Street, Silverdale, approximately 22 metres east of the junction of Crown Street and Church Street and running in a generally northerly direction for approximately 23m. then in a generally north-easterly direction for approximately 17m. to its terminus approximately 6m. south of the junction of public footpaths nos.18 and 19 Silverdale Parish (point C on the attached plan).

PART 3

LIMITATIONS AND CONDITIONS

A gate and A-Frame sited at point B (382276 346665) and a gate and A-Frame sited at point C (382290 346683) on the Order plan. The surface of the new Cycle Track is tarmacadam and is publically maintainable.

No other works are required to bring this route into a fit condition for public use.
