PUBLIC FOOTPATH NO. 7 (PART), 8 AND 9 (PART) SWINDON PARISH PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2017

This Order is made by Staffordshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpaths described in paragraph 1 of this Order, it is expedient that the lines of the paths should be diverted.

This Order is also made under Section 53A(2) of the Wildlife & Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the District of South Staffordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely the diversion (as authorised by this Order) of highways shown or required to be shown in the Map and Statement.

The landowner F.G. Davis & Sons has agreed to defray any expenses which are incurred in bringing the new site of the paths into a fit condition or use by the public.

South Staffordshire Council have been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

- 1. The public rights of way over the land situate at Swindon Parish and shown by bold continuous lines on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order, and thereupon the Definitive Map for the District of South Staffordshire shall be modified by deleting from it those public rights of way.
- 2. There shall, at the end of 28 days from the date of confirmation of this Order, be public footpaths over the land situate at Swindon Parish described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this Order and thereupon the Definitive Map for the District of South Staffordshire shall be modified by adding those paths to it.
- 3. The Definitive Statement for the District of South Staffordshire shall be modified as described in Part 4 of the Schedule to this Order.

4. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of Public Footpath No. 7 Swindon Parish running from point A on the Order plan (387049, 289946) in a generally east south-easterly direction for approximately 194 metres to point B on the Order plan (387231, 289874).

That length of Public Footpath No. 8 Swindon Parish running from its junction with Public Footpath No. 9 Swindon at point C on the Order plan (387340, 289963) in a generally southerly direction for approximately 25 metres to point D on the Order plan (387343, 289940).

That length of Public Footpath No. 9 Swindon Parish running from point E on the Order plan (387140, 289966) in a generally easterly direction for approximately 252 metres to point F on the Order plan (387394, 289970).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A new length of Public Footpath No. 7 Swindon Parish running from point A on the Order plan (387049, 289946) and heading in a generally southerly direction for approximately 16 metres before turning to head in a generally east south-easterly direction for approximately 136 metres to point G on the Order plan (387185, 289904) before heading in a generally north easterly direction for approximately 148 metres to its junction with the new route of Public Footpath No 9 Swindon at point H on the Order plan (387313, 289981).

A new length of Public Footpath No. 8 Swindon Parish running from its new junction with Public Footpath No. 9 Swindon at point J on the Order plan (387344, 289977) in a generally south south-westerly direction for approximately 43 metres before heading in a generally south south-easterly direction for approximately 13 metres to point K on the Order plan (387337, 289924).


A new length of Public Footpath No. 9 Swindon Parish running from point E on the Order plan (387140, 289966) in a generally east north-easterly direction for approximately 86 metres to point M on the Order plan (387221, 290002) before heading in a generally east south-easterly direction for approximately 178 metres to point F on the Order plan (387394, 289970).

The new routes shall have prescribed widths of 1.8 metres between points A-G-H; J-K; and E-M-H-J-F.
