**PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER 2016**

This Order is made by Staffordshire County Council (“the authority”) under Section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interests of the owner of the land crossed by the footpaths described in paragraph 1 of this Order, it is expedient that the line of the paths should be diverted.

This Order is also made under Section 53A(2) of the Wildlife & Countryside Act 1981 (“the 1981 Act”) because it appears to the authority that the Definitive Map and Statement for the Borough of Tamworth require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely the diversion (as authorised by this Order) of highways shown or required to be shown in the Map and Statement.

Staffordshire County Council and Tamworth Borough Council has agreed to defray any expenses which are incurred in bringing the new site of the paths into a fit condition for use by the public.

Tamworth Borough Council have been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public right of way over the land situate at Tamworth Borough and shown by bold continuous lines on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order, and thereupon the Definitive Map for the Borough of Tamworth shall be modified by deleting from it those public rights of way.

2. There shall, at the end of 28 days from the date of confirmation of this Order, be public footpaths over the land situate at Tamworth Borough described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this Order and thereupon the Definitive Map for the Borough of Tamworth shall be modified by adding those paths to it.

3. The Definitive Statement for the Borough of Tamworth shall be modified as described in Part 4 of the Schedule to this Order.

4. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of Public Footpath No 108 Tamworth running from a point approximately 110 metres north of the River Anker at point A on the Order plan (422512 305655) and heading in a generally easterly direction for approximately 470 metres to its junction with Public Footpath No 109 Tamworth at point L on the Order plan (422963 305529).

That length of Public Footpath No 109 Tamworth running from a point approximately 110 metres north of the River Anker at point D on the Order plan (422987 305509) and heading in a generally easterly direction through the grounds of Amington Hall Farm for approximately 134 metres to its junction with Public Footpath No 112 Tamworth at point M on the Order plan (423107 305447) then turning in a generally southerly then easterly direction for approximately 104 metres to point E on the Order plan (423171 305387). The footpath then continues in a generally east south-easterly direction for approximately 100 metres to point N on the Order plan (423261 305344) before heading in a generally north-easterly direction for approximately 247 metres to its junction with Public Footpath No 111 Tamworth at point G on the Order plan (423505 305369).

That length of Public Footpath No 110 Tamworth which runs from its junction with Public Footpath No 109 Tamworth at point N on the Order plan (423261 305344) in a generally east south-easterly direction for approximately 133 metres to point J on the Order plan (423369 305265).

That length of Public Footpath No 112 Tamworth which runs from its junction with Public Footpath No 109 Tamworth at point M on the Order plan (426107 305447) in a generally north easterly direction for approximately 742 metres to its junction with Public Footpath No 111 Tamworth at point P on the Order plan (423696 305848).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A new length of Public Footpath No 108 Tamworth running from a point approximately 112 metres north of the River Anker via a gap in the hedge at point A on the Order plan (422512 305655) and heading in a generally easterly direction for approximately 295 metres to a new kissing gate at point B on the Order plan (422773 305512) and continuing in a generally easterly direction for a further 271 metres to its junction with the realigned route of Public Footpath No 109 Tamworth and a kissing gate at point C on the Order plan (423023 305422).

A new length of Public Footpath No 109 Tamworth running from a point approximately 110 metres north of the River Anker at point D on the Order plan (422987 305509) in a generally south easterly direction for approximately 92 metres to a kissing gate at point C on the Order plan (423023 305422) before heading in a generally easterly direction for approximately 147 metres through a wicket gate at point E on the Order plan (423171 305387) and joining the farm track to continue in a generally easterly direction for approximately 117 metres to its junction with the realigned Public Footpath No 112 Tamworth at point F on the Order plan (423279 305355) before continuing along the farm track in a generally north easterly direction for approximately 245 metres to its junction with Public Footpath No 111 Tamworth at point G on the Order plan (423505 305369).

A new length of Public Footpath No 110 Tamworth running from its junction with the realigned Public Footpath No 110 and 112 Tamworth at point F on the Order plan (423279 305355) and heading in a generally south easterly direction for approximately 126 metres to its original junction with Public Footpath No 110 Tamworth at point J on the Order plan (423369 305265).

A new length of Public Footpath No 112 Tamworth running from its junction with the realigned Public Footpath No 109 and 110 Tamworth at point F on the Order plan (423279 305355) and heading in a generally north easterly direction for approximately 115 metres to kissing gate and crossing over a stream at point H on the Order plan (423352 305446). The footpath then continues for approximately 606 metres in a generally northerly direction adjacent to the stream at the western edge of the field before reaching its original junction with Public Footpath No 111 Tamworth at point P on the Order plan (423696 305848).

The new route of Public Footpath No 108 Tamworth shall have a prescribed width of 1.8 metres between points A-B-C other than when passing through the new kissing gate at point B (422773 305512).

The new route of Public Footpath No 109 Tamworth shall have a prescribed width of 1.8 metres between points C and E and a width of 2.5 metres when running along the farm track between points E-F-G.

The new route of Public Footpath No 110 Tamworth shall have a prescribed width of 2.5 metres between points F and G.

The new route of Public Footpath No 112 Tamworth shall have a prescribed width of 2.5 metres between points F-H-P other than when crossing the footbridge at point H (423352 305446).

PART 3

LIMITATIONS AND CONDITIONS

Pedestrian kissing gates in accordance with BS5709:2006 will be installed at points B (422773 305512), C (423023 305422), and H (423352 305446) on the Order plan..

Pedestrian wicket gate in accordance with BS5709:2006 will be installed at point E (423171 305387) on the Order plan.

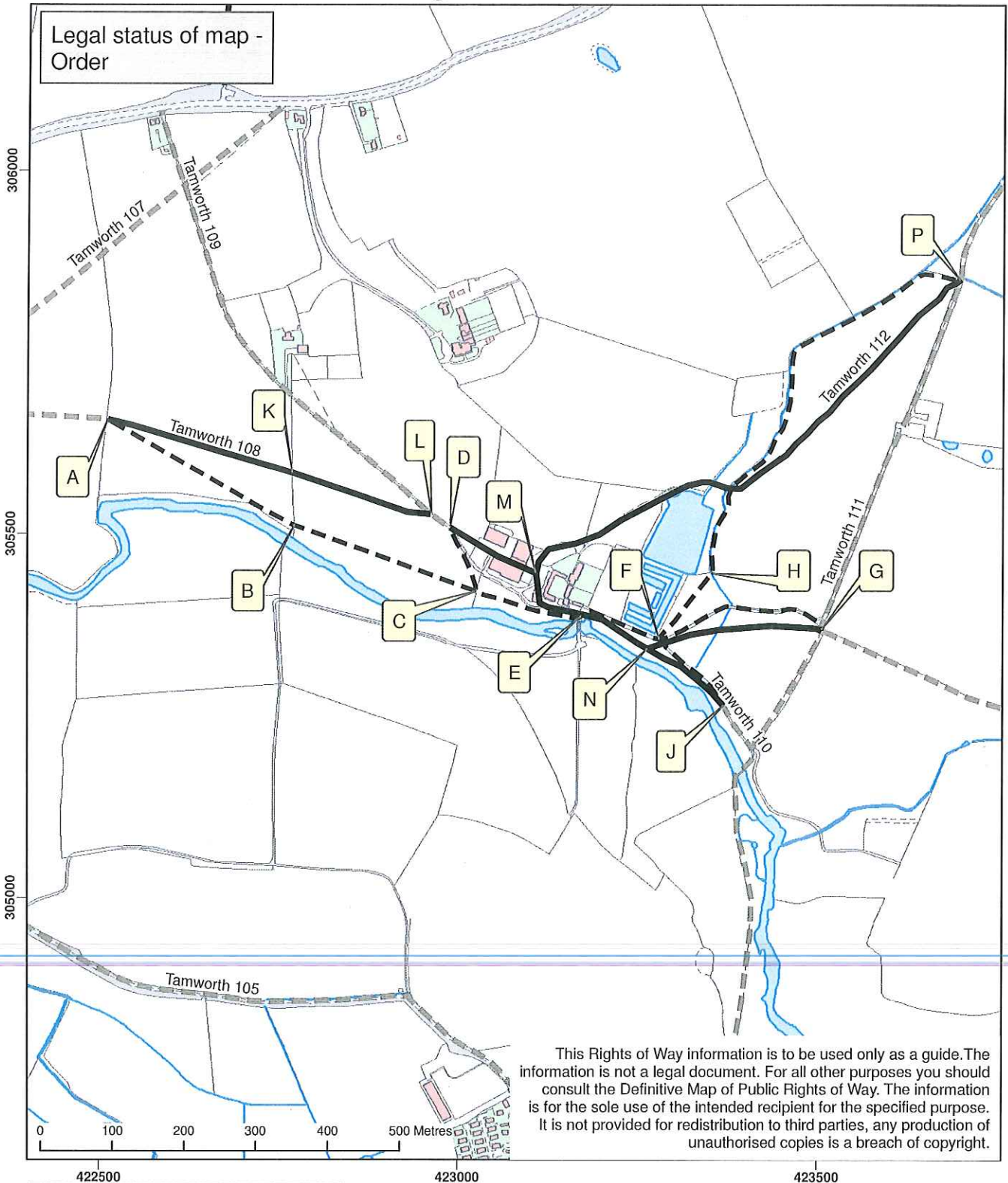
