DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER**

**HIGHWAYS ACT 1980
WILDLIFE & COUNTRYSIDE ACT 1981**

PUBLIC BRIDLEWAY NO. 28 CASTLE CHURCH PARISH)
PUBLIC PATH DIVERSION AND
DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2016**

This Order is made by Staffordshire County Council ('the authority') under Section 119 of the Highways Act 1980 ('the 1980 Act') because it appears to the authority that, in the interests of the owner of the land crossed by the footpath and bridleways described in paragraph 1 of this Order, it is expedient that the lines of the footpath and bridleways should be diverted.

This Order is also made under Section 53A (2) of the Wildlife & Countryside Act 1981 ('the 1981 Act') because it appears to the authority that the Definitive Map and Statement for the Districts of South Staffordshire and the Borough of Stafford require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely the diversion (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

The landowner and the County Council have agreed to defray any expenses which are incurred in bringing the new site of the paths into a fit condition for use by the public.

South Staffordshire District Council and Stafford Borough Council have been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act:

BY THIS ORDER

1. The public rights of way over the land situate at Coppenhall and at Castle Church shown by bold continuous lines on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order, and thereupon the Definitive Maps for the Districts of South Staffordshire and Stafford Borough shall be modified by deleting from them those public rights of way.

2. There shall, at the end of 28 days from the date of confirmation of this Order, be a public footpath and a public bridleway over the land situate at Coppenhall described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this Order and thereupon the Definitive Map for the District of South Staffordshire shall be modified by adding those paths to it.

3. The Definitive Statement for Parish of Coppenhall in the District of South Staffordshire shall be modified as described in Part 4 of the Schedule to this Order.

4. The Definitive Statement for the Parish of Castle Church in the Borough of Stafford shall be modified as described in Part 5 of the Schedule to this Order

5. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of Public Footpath No. 6 Coppenhall Parish which runs from point J on the Order plan (390647 320314) in a generally westerly direction for approximately 490 metres to its junction with Bigwood Lane at point B on the Order plan (390165 320376).

That length of Public Bridleway No. 7 Coppenhall Parish which runs from its junction with Public Footpath No. 6 Coppenhall and Public Bridleway No. 13 Coppenhall Parish at point A on the Order plan (390826 320314) in a generally north-westerly direction for approximately 539 metres to its junction with Public Bridleway No. 28 Castle Church Parish at point C on the Order plan (390425 320670).

That length of Public Bridleway No. 28 Castle Church Parish which runs from its junction with Public Bridleway No. 7 Coppenhall Parish at point C on the Order plan (390425 320670) in a generally westerly direction for approximately 50 metres to its junction with Thorneyfields Lane at point H on the Order plan (390377 320677).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A new length of Public Footpath No. 6(a) Coppenhall Parish which runs from its junction with Public Bridleway No.13 Coppenhall at point D on the attached plan (390715 319976) in a generally north-north-westerly direction for approximately 457 metres to point E on the Order plan (390515 320364).

A new length of Public Bridleway No. 7 Coppenhall Parish which runs from a new junction with Bigwood Lane at point F on the Order plan (390274 320477) in a generally east-south-easterly direction for approximately 267 metres to a point at the north-western edge of the moated site at point E on the Order plan (390515 320364) before heading around the northern perimeter of the site and associated fishpond in a generally east-north-easterly direction for approximately 318 metres to its junction

with Public Bridleway No. 0.1287 Castle Church Parish at point G on the Order plan (390777 320488).

The new route of Public Footpath No 6(a) Coppenhall shall have a prescribed width of 2 metres between points D and E on the Order plan.

The new route of Public Bridleway No 7 Coppenhall shall have a prescribed width of 3 metres between points F, E and G on the Order plan.

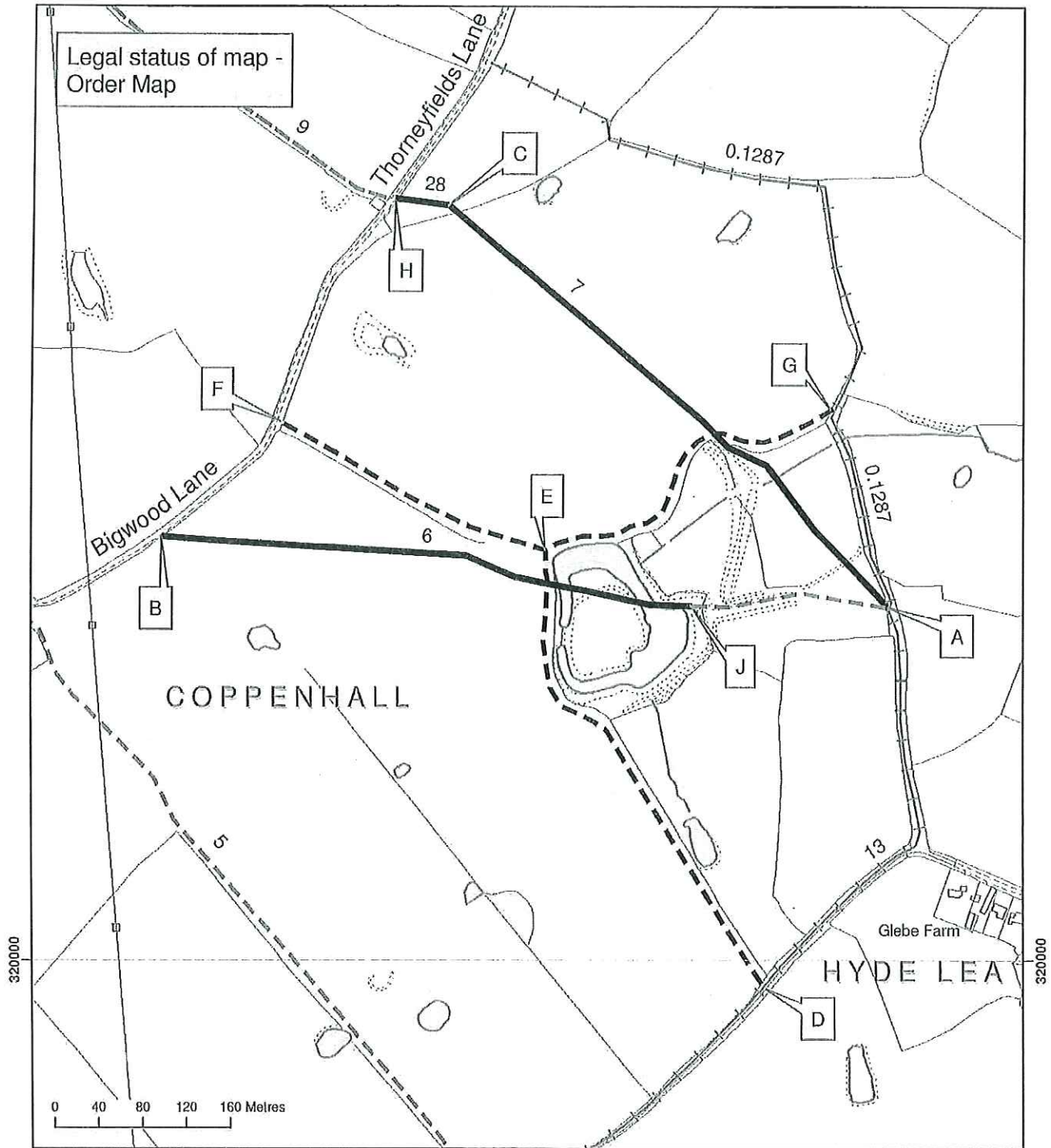
