## **Public Path Extinguishment Order**

This Order is made by Staffordshire County Council ("the Authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that the footpaths described in paragraph 1 of this Order are not needed for public use.

Newcastle Under Lyme Borough Council has been consulted to the making of the Order as required by section 120(2) of the 1980 Act.

#### BY THIS ORDER

- 1. The public rights of way over land situate at Silverdale and shown by a bold continuous line on the map contained in this Order and described in Part I of the Schedule to this Order shall be extinguished after 28 days from the date of confirmation of this order.
- 2. Notwithstanding this Order where immediately before the date upon which the footpath is extinguished there is apparatus under, in, on, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

# Description of paths to be extinguished

The entire length of Public Footpath No. 11, Silverdale Parish commencing at its junction with Buxton Avenue and Moffatt Way (point A on the Order map, Grid Ref:SJ810466) and running in a generally easterly direction for approximately 115 metres along Buxton Avenue, to a point approximately 93 metres north of St. Luke's C. of E. Primary School (point B on the Order map, Grid Ref: SJ811467) then proceeding in a generally north-easterly direction for approximately 78 metres through properties 16 and 18 Buxton Avenue and the garden of Park House, Scot Hay Road, exiting at a point opposite Public Footpath No. 10, Silverdale Parish, point C on the Order map, Grid Ref:SJ812467.




