### (PUBLIC BRIDLEWAY NO. 26 (PART) BLORE WITH SWINSCOE PARISH) PUBLIC PATH EXTINGUISHMENT AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2016

This Order is made by Staffordshire County Council ("the authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the public bridleway is not needed for public use.

This order is also made under section 53A (2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the definitive map and statement for the District of Staffordshire Moorlands require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the extinguishment (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Staffordshire Moorlands District Council and the Peak District National (Park) Authority have been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

#### BY THIS ORDER

- 1. The public right of way over the land situate at Blore with Swinscoe and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order, and thereupon the definitive map for the District of Staffordshire Moorlands shall be modified by deleting from it that public right of way.
- 2. The definitive statement for Staffordshire Moorlands District shall be modified as described in Part 2 of the Schedule to this order.


