## PUBLIC BRIDLEWAY NO.0.1517 (PART) HIGH OFFLEY PARISH PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2016

This order is made by Staffordshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owners of the land crossed by the bridleway as described in paragraph 1 of this Order, it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A (2) of the Wildlife & Countryside Act 1981 (the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the Borough of Stafford requires modification in consequence of the occurrence of an event specified in Section 53(3) (a) (i) of the 1981 Act, namely the diversion (as authorised by this Order) of highways shown or required to be shown in the Map and Statement.

The landowner has agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Stafford Borough Council has been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

#### BY THIS ORDER

- 1. The public bridleway over the land situated at High Offley and shown by a bold continuous line on the map contained in this Order and described in part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order, and thereupon the Definitive Map for the Borough of Stafford shall be modified by deleting from it that public right of way.
- 2. There shall, at the end of 28 days from the date of confirmation of this Order, be a public bridleway over the land situate at High Offley described in part 2 of the Schedule and shown by a bold broken line on the map contained in this Order and thereupon the Definitive Map for the Borough of Stafford shall be modified by adding the path to it.
- 3. The Definitive Statement for the Borough of Stafford shall be modified as described in part 4 of the Schedule to this Order.
- 4. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

#### **SCHEDULE**

#### PART 1

#### DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of Public Bridleway No.0.1517 High Offley Parish commencing from the junction with Public Bridleway No. 0.1522 High Offley Parish at point B on the Order plan (375785, 326067) and continuing in a generally northerly direction for approximately 82 metres passing the former Wharf Inn Public House to point A on the Order plan (375744, 326121).

#### PART 2

#### DESCRIPTION OF SITE OF NEW PATH OR WAY

A new length of Public Bridleway No.0.1517 High Offley Parish which commences at its junction with Bridleway No.01522 High Offley Parish at point C on the Order plan (375767, 326067) and continues in a generally northerly direction to point A on the Order plan (375744, 326121).

The new route of Public Bridleway No. 0.1517 High Offley Parish shall have a prescribed width of 3 metres between points C (375767, 326067) and A (375744, 326121) on the Order plan.





The landowner has agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Stafford Borough Council has been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

#### BY THIS ORDER

- 1. The public bridleway over the land situated at High Offley and shown by a bold continuous line on the map contained in this Order and described in part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order, and thereupon the Definitive Map for the Borough of Stafford shall be modified by deleting from it that public right of way.
- 2. There shall, at the end of 28 days from the date of confirmation of this Order, be a public bridleway over the land situate at High Offley described in part 2 of the Schedule and shown by a bold broken line on the map contained in this Order and thereupon the Definitive Map for the Borough of Stafford shall be modified by adding the path to it.
- 3. The Definitive Statement for the Borough of Stafford shall be modified as described in part 4 of the Schedule to this Order.
- 4. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

The new route of Public Bridleway No. 0.1517 High Offley Parish shall have a prescribed width of 3 metres between points C (375767, 326067) and A (375744, 326121) on the Order plan.


