**PUBLIC FOOTPATH NO.11 (PART) BURNTWOOD TOWN
PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND
STATEMENT MODIFICATION ORDER 2016**

This order is made by Staffordshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpath as described in paragraph 1 of this Order, it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A (2) of the Wildlife & Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the District of Lichfield require modification in consequence of the occurrence of an event specified in Section 53(3) (a) (i) of the 1981 Act, namely the diversion (as authorised by this Order) of highways shown or required to be shown in the Map and Statement.

The landowner has agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition or use by the public.

Lichfield District Council has been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public right of way over the land situate at Burntwood Town and shown by a bold continuous line on the map contained in this Order and described in part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order, and thereupon the Definitive Map for the District of Lichfield shall be modified by deleting from it that public right of way.
2. There shall, at the end of 28 days from the date of confirmation of this Order, be a public footpath over the land situate at Burntwood Town described in part 2 of the Schedule and shown by a bold broken line on the map contained in this Order and thereupon the Definitive Map for the District of Lichfield shall be modified by adding the path to it.
3. The Definitive Statement for the District of Lichfield shall be modified as described in part 4 of the Schedule to this Order.
4. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of Public Footpath No.11 Burntwood Town commencing at a field gate at Lichfield Road at point A on the Order plan 408046, 308672 and continuing in a generally north north-westerly direction for approximately 11 metres into the yard of Edial Hall to point B on the Order plan 408044, 308682 and continuing in a generally north easterly direction for approximately 28 metres to point C on the Order plan 408062, 308703 and continuing in a generally north north-westerly direction for approximately 17 metres to field gate at point D on the Order plan 408059, 308719 and continuing in a generally northerly direction through a meadow for approximately 82 metres to a stile at point E on the Order plan 408064, 308801.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A new length of Public Footpath No.11 Burntwood Town commencing at a wicket gate at Lichfield Road at point at point F on the Order plan 408115, 308693 and continuing in a generally north north-westerly direction for approximately 27 metres along side the fence and hedge line of a grassy field east of Edial Hall to point G on the Order plan 408100, 308716 and continuing in a generally north north-easterly direction for approximately 39 meters to a wicket gate at point H on the Order plan 408106, 308754 and continuing through the wicket gate and across a field in a generally north westerly direction for approximately 64 metres to a stile at point E on the Order plan 408064, 308801.

The new route of Public Footpath No.11 Burntwood Town shall have a prescribed width of 1.8 metres between points F – G – H - E other than when passing through the wicket gates at points F on the Order plan 408115, 308693 and H on the Order plan 408106, 308754.

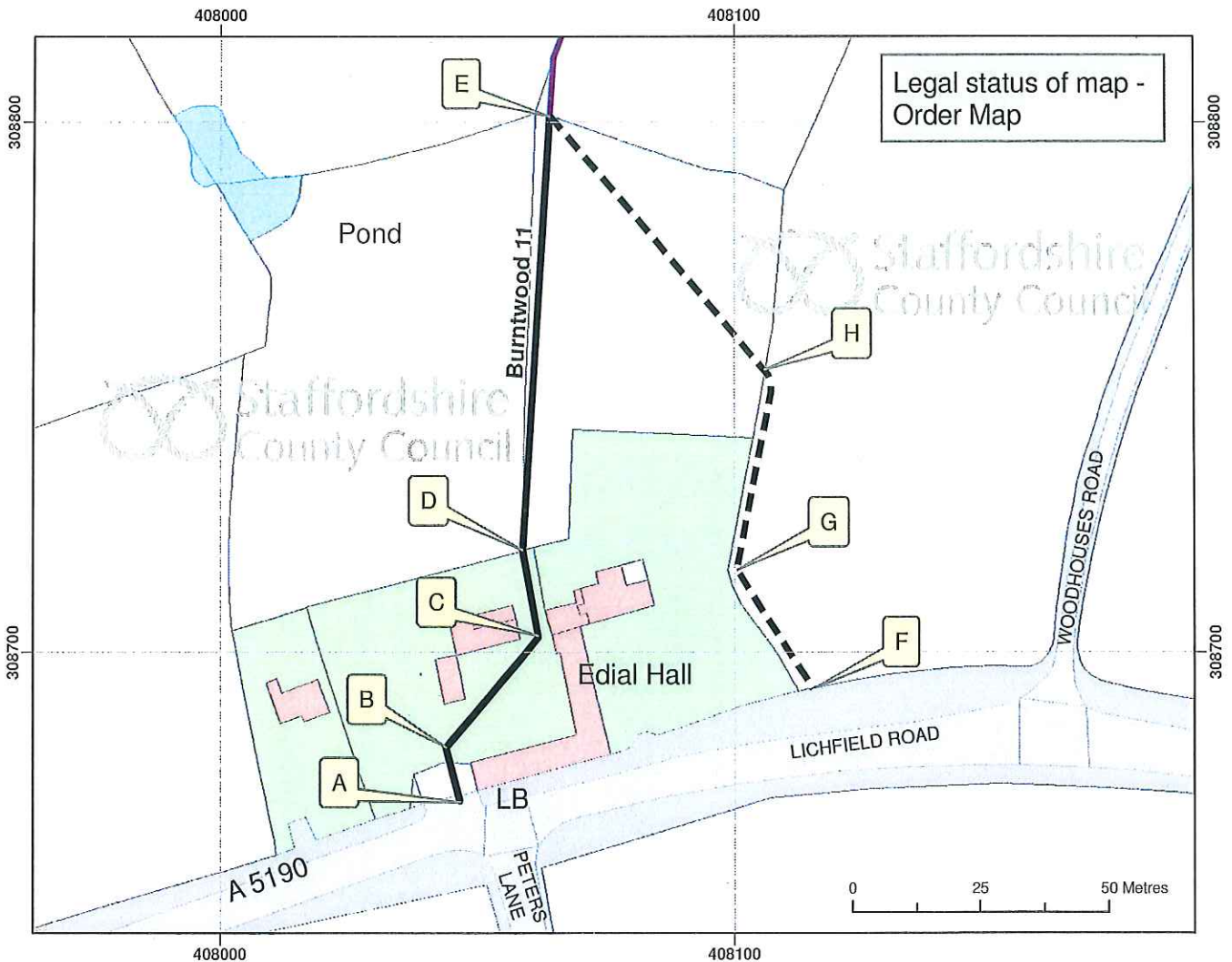

BY THIS ORDER

There shall, at the end of 28 days from the date of confirmation of this Order, be a public footpath over the land situate at Burntwood Town described in part 2 of the Schedule and shown by a bold broken line on the map contained in this Order and thereupon the Definitive Map for the District of Lichfield shall be modified by adding the path to it.
3. The Definitive Statement for the District of Lichfield shall be modified as described in part 4 of the Schedule to this Order.
4. The rights conferred on the public under this Order shall be subject to the Limitations and Conditions set out in Part 3 of the Schedule.

That length of Public Footpath No.11 Burntwood Town commencing at a field gate at Lichfield Road at point A on the Order plan 408046, 308672 and continuing in a generally north north-westerly direction for approximately 11 metres into the yard of Edial Hall to point B on the Order plan 408044, 308682 and continuing in a generally north easterly direction for approximately 28 metres to point C on the Order plan 408062, 308703 and continuing in a generally north north-westerly direction for approximately 17 metres to field gate at point D on the Order plan 408059, 308719 and continuing in a generally northerly direction through a meadow for approximately 82 metres to a stile at point E on the Order plan 408064, 308801.

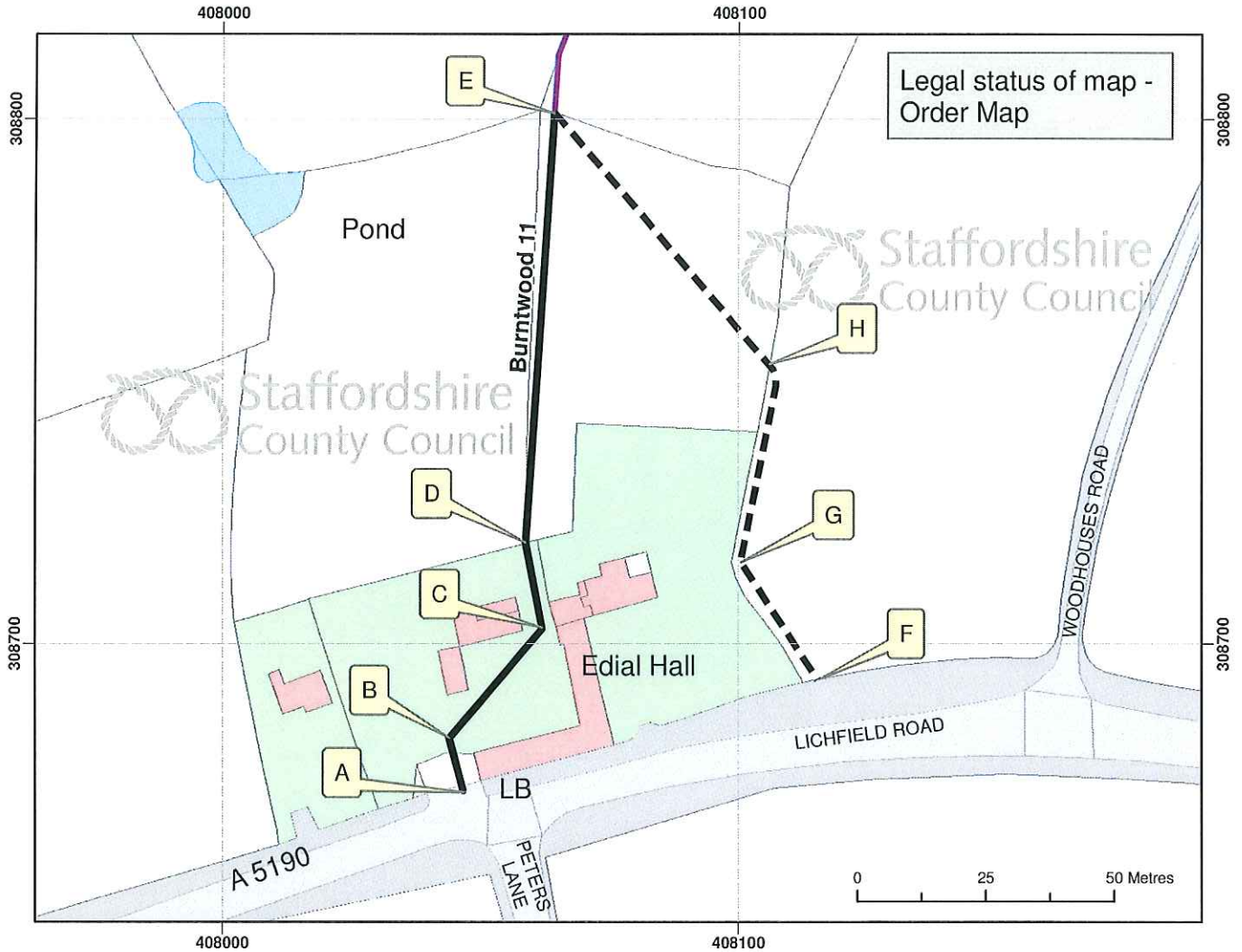
