**PUBLIC FOOTPATH NO.29 (PART) MAVESYN RIDWARE PARISH  
PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND  
STATEMENT MODIFICATION ORDER 2016**

This order is made by Staffordshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpath as described in paragraph 1 of this Order, it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A (2) of the Wildlife & Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for the District of Lichfield require modification in consequence of the occurrence of an event specified in Section 53(3) (a) (i) of the 1981 Act, namely the diversion (as authorised by this Order) of highways shown or required to be shown in the Map and Statement.

The landowner has agreed to defray any expenses which are incurred in bringing the new site of the paths into a fit condition or use by the public.

Lichfield District Council has been consulted as to the making of the Order as required by Section 120(2) of the 1980 Act.

**BY THIS ORDER**

1. The public rights of way over the land situate at Mavesyn Ridware and shown by a bold continuous line on the map contained in this Order and described in part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order, and thereupon the Definitive Map for the District of Lichfield shall be modified by deleting from it that public right of way.
2. There shall, at the end of 28 days from the date of confirmation of this Order, be a public footpath over the land situate at Mavesyn Ridware described in part 2 of the Schedule and shown by bold broken lines on the map contained in this Order and thereupon the Definitive Map for the District of Lichfield shall be modified by adding the path to it.
3. The Definitive Statement for the District of Lichfield shall be modified as described in part 4 of the Schedule to this Order.
4. The rights conferred on the public under this Order shall be subject to the Limitations and conditions set out in Part 3 of the Schedule.

## **SCHEDULE**

### **PART 1**

#### **DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

That length of Public Footpath No.29 Mavesyn Ridware Parish commencing from Pipe Lane at point A on the Order plan grid reference 409573 317708 and continuing in a generally easterly direction for approximately 7 metres through an opening in the former St James church yards western perimeter wall at point B on the Order plan grid reference 409580 317708 and continuing in a generally north-easterly direction for approximately 92 metres through the burial grounds to a stile in the eastern perimeter fence line at point C on the Order plan grid reference 409658 317752 and continuing in a north north – westerly direction for approximately 24 metres to its junction with Public Footpath No.18 Mavesyn Ridware at point D on the Order plan grid reference 409664 317776.

### **PART 2**

#### **DESCRIPTION OF SITE OF NEW PATH OR WAY**

A new length of Public Footpath to be named upon confirmation of the Order as No.29(a) Mavesyn Ridware Parish commencing from Pipe Lane at point A on the Order plan grid reference 409573 317708 and continuing in a generally easterly direction for approximately 7 metres through at an opening in the former St James church yard's western perimeter wall at point E on the Order plan grid reference 409580 317708 and continuing in a generally easterly direction along the former church yard's southern boundary fence line for approximately 80 metres to a kissing gate in the eastern perimeter wall at point F on the Order plan grid reference 409659 317695 and continuing in a generally easterly direction for approximately 5 metres to its junction with Public Footpath No.18 and Public Footpath No.30 Mavesyn Ridware at point G on the Order plan grid reference 409663 317694.

The new route of Public Footpath No.29 Mavesyn Ridware Parish shall have a prescribed width of 1.8 metres between points A – E – F - G other than when passing through the opening in the former church yards wall at point E on the Order plan grid reference 409580 317708 and through the Kissing gate at point F on the Order plan grid reference 409659 317695.

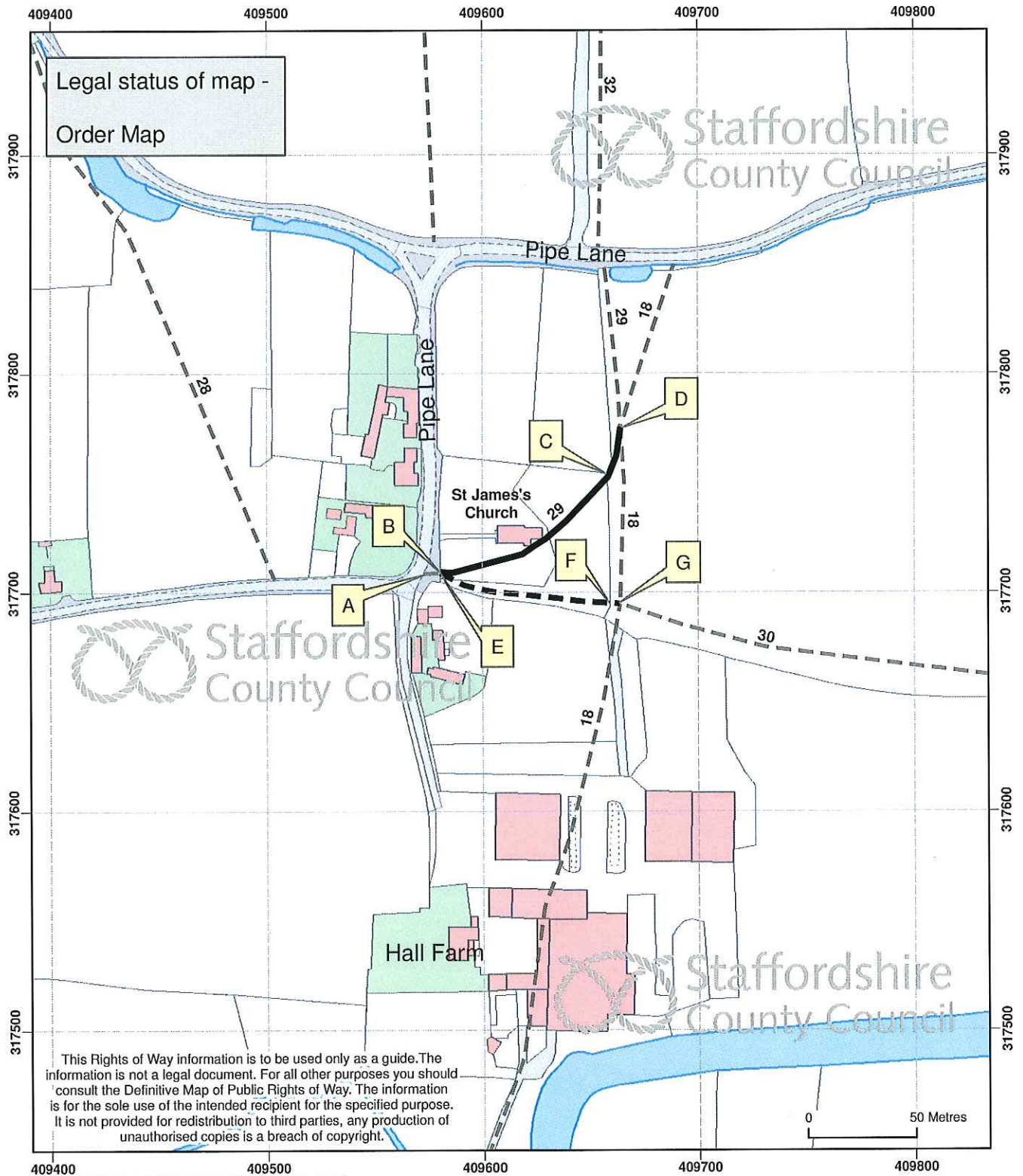
#### **LIMITATIONS AND CONDITIONS**
