**WILDLIFE AND COUNTRYSIDE ACT 1981**

**Staffordshire County Council (Public Footpath between BOAT 23 and Pipe Green

Modification Order 2014**

This Order is made by Staffordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement for the District of Lichfield require modification in consequence of the occurrence of events specified in:

Section 53(3)(c)(i) namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which this Part applies.

Section 53(c)(iii) namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars described in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. The Staffordshire County Council hereby order that:

1. For the purposes of this Order the relevant date is the date it is made.
2. The Definitive Map and Statement for the District of Lichfield shall be modified as described in Part I and Part II of the Schedule and shown on the Map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Staffordshire County Council (Public Footpath between BOAT 23 and Pipe Green Common, Lichfield City) Modification Order 2014.

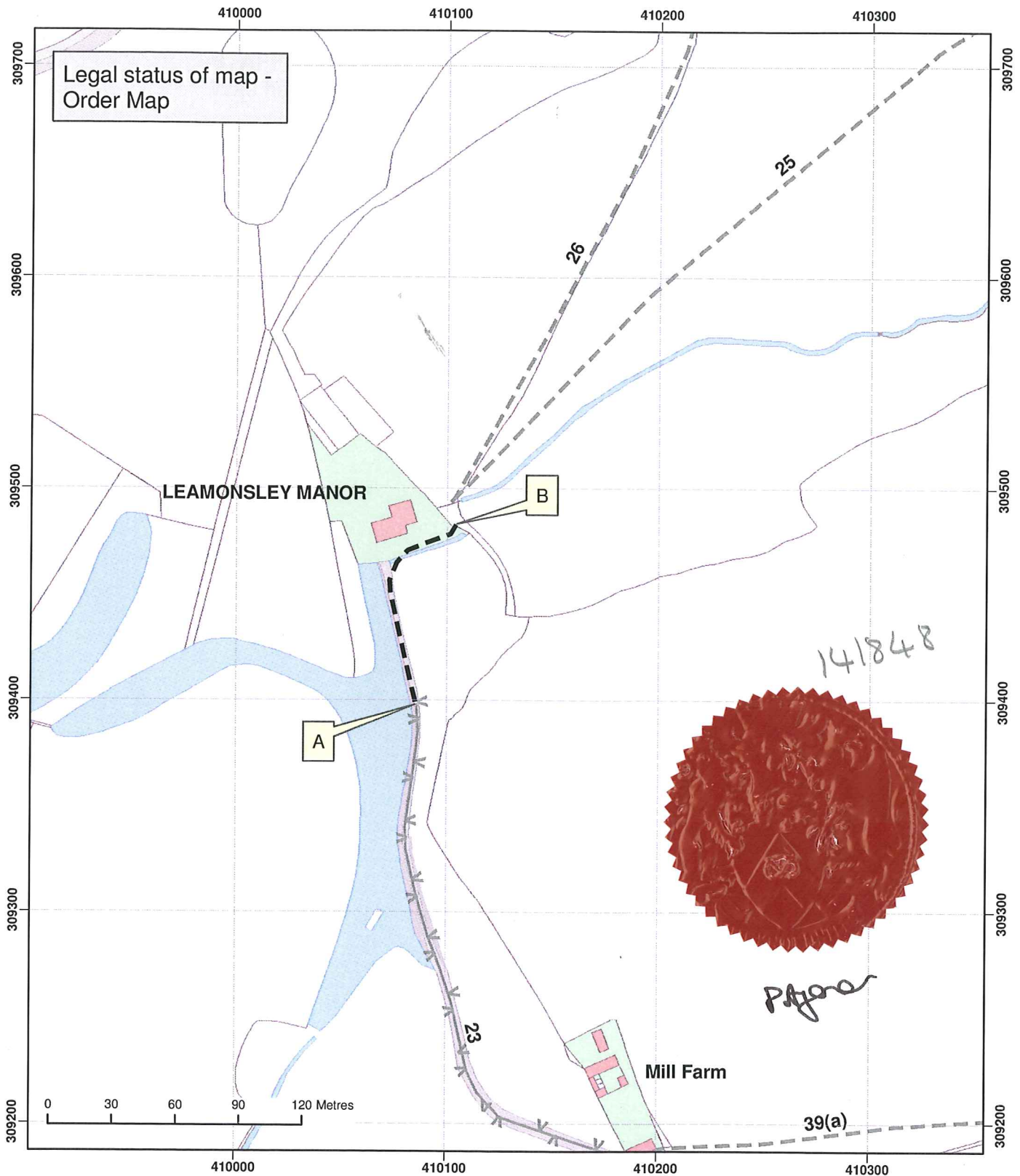
