This Order is made by Staffordshire County Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the public, it is expedient that the line of the path should be diverted.

#### BY THIS ORDER

- 1. The public right of way over land situate at Chapel and Hill Chorlton Parish and shown by a bold continuous line on the map contained in this Order and described in Part I of the Schedule to this Order shall be stopped up after, as provided below.
- 2. Notwithstanding this Order where immediately before the date upon which the footpath is diverted there is apparatus under, in, on, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.
- 3. There shall be created to the reasonable satisfaction of Staffordshire County Council an alternative highway for use as a replacement for the said footpath as provided in Part II of the Schedule and shown by a bold broken line on the map contained in this Order.
- 4. The diversion of the footpath shall have effect on the date which Staffordshire County Council certify that the terms of Part II of the Schedule have been complied with.
- 5. The rights conferred upon the public under this Order shall be subject to any limitations and conditions set out in Part III of the Schedule.

#### Schedule

#### Part I


That length of Public Footpath No. 14 Chapel and Hill Chorlton Parish commencing from its original junction with School Bank (point A on the plan) and running in a generally northerly direction for approximately 14 metres to the south-eastern corner of St Lawrence Church (point B on the plan).

#### Part II

That length of Public Footpath No. 14 Chapel and Hill Chorlton Parish commencing from the main entrance to St Lawrence Church on School Bank (point C on the plan) and running in a generally easterly direction around the southern edge of St Lawrence Church to meet the original definitive line of the footpath at the south-eastern corner of the Church (point B on the plan).
