2. Parts A and F must be completed in all cases.

The form must be signed and dated by, or by a duly authorised representative of, every owner of land to which the application relates who is an individual, and by the secretary or some other duly authorised officer of every owner of land to which the application relates which is a body corporate or an unincorporated association.

4. In the case of land in joint ownership, all the joint owners must complete paragraphs 2 and 3 of Part A and complete and sign the application in Part F, unless a duly authorised representative completes and signs the form on behalf of all of the owners of the land. Paragraph 3 should be completed in full to clearly explain the capacity of each applicant, e.g. trustee, landowner's managing agent, executor.

5. 'Owner' is defined in Section 61(3) of the Commons Act 2006 and Section 31(7) of the Highways Act 1980 and means, broadly, a legal owner of the freehold interest in the land.

6. 7. Where a statement or declaration requires reference to colouring shown on an accompanying map or previously lodged map, the colouring must be clearly specified and must match that shown on the relevant map. 'Appropriate authority' means (a) in relation to a map or statement deposited or declaration lodged under Section 31(6) of that Act, an appropriate council (as defined in Section 31(7) of the Highways Act 1980); and (b) in relation to a statement and map deposited under Section 15A(1) of the 2006 act, a commons registration authority (defined in Section 4 of the Commons Act 2006 and Section 2 of the Commons Registration Act 1965). In practice, the appropriate council and commons registration authority will usually be the same body.
