

Evidence required to determine EYPP eligibility

Requesting UC evidence

Two screenshots will be required as evidence. These are noted in red.

- 1.) Parent/Carer will need to log onto their online UC Gateway account and choose the **most recent** statement (or the one dated as close to the start of term, if appropriate).

This will open the screen with a large, coloured box at the top displaying the amount and date of the payment. The statement is usually published approx. 7 days in advance of any payment and payments are received monthly.



- 2.) Further down on the same page there is a section called Help and Support. Please look for the sub-section called 'Other support you may be able to get'. (Fig 2)



Child Tax Credit Award letter

(provided parent is not also in receipt of Working Tax Credit)

Most claimants have been transferred to UC but if a family in receipt of CTC, you will need to provide the Child Tax Credit award letter which is issued once a year in April and details the payments to follow that year and how they have been calculated. ALL pages are required.

Job Seekers Allowance

There are 2 forms of JSA- Contribution based and Income based. If a parent is in receipt of Contribution based they are NOT eligible (can be seen on page 4 of letter):-
