CX065 - Notification of carriageway resurfacing works on the D4324 Poplar Lane, Cannock

As part of the Council's ongoing investment into its roads in Staffordshire, Amey Services Ltd working with Staffordshire County Council, will shortly begin carrying out works along the D4324, Poplar Lane, Cannock (junction of Hatton Road to property Squirrels Rest on Poplar Lane). Works will include minor civil works, which include, cutting back overhanging tree canopies from the carriageway, replacement and adjustments of kerbs where necessary, along with the removal of the existing carriageway ironworks and re-setting them. Following the above works, we will then begin the carriageway resurfacing works, along with the replacement of new road markings.

Beginning on **Monday 2 March 2026**, we'll begin the first phase of the scheme, where we'll start the civil works.

These initial works will be carried out under a daytime road closure between the hours of **7.30am** and **4.00pm**. Outside of these times the road will remain open.

The civil works are due to be completed on **Wednesday 11 March 2026**.

From **Thursday 12 March 2026** we will begin our carriageway resurfacing works. This will include, utility survey works, the removal of the existing carriageway surface and replacing it with a new surface, along with the replacement of new road markings. During these works, Poplar Lane will be closed from the junction of Hatton Road to Church Lane. The road closures will be in place 24 hours a day (Monday to Friday), this is due to the size and scale of construction machines being used and to allow materials to be removed and cured. This is for the safety of the general public and workforce. The carriageway resurfacing works are due to be completed on **Friday 20 March 2026**.

For the number of properties within the work area, access will be via the local diversion route.

A signed diversion route will be in place during the closures; along with designated personnel at either end of the closure points to offer assistance with residential properties access. Please speak to the site team, so that we can help with any specific needs or requirements you may have during this works.

Please plan ahead and allow extra time for your journeys.

Emergency services will be given access through the road closures when safe to do so.

There will be times during the carriageway resurfacing works that pedestrian access along the length of the works will not be available due to the size and scale of construction machines being used.

Please allow extra time for your journeys and, where possible, please use alternative routes to avoid delays. Please do not ignore road closure signage.

Unfortunately, with any major highway works, some disturbance is unavoidable, and there may be short delays even on the approaches to the closure points. We must ask that you drive carefully and slowly through any sections of live roadworks for both the workforces and your own safety.

During the road closure period, waste and recycling collections will remain the same, on their normal collection days.

Please note that all dates are subject to change due to operational requirements and weather conditions. Weekend working may be used where necessary.

The works may at times be noisy, and we apologise in advance for any inconvenience or disturbance caused. We'll do our best to complete the work as quickly and safely as possible. We like to thank you for your patience during this works.
